The following incident occurred in Broward County Florida on the date of 12-12-21. I, [REDACTED], was performing my law enforcement duties as a member of the FHP. I was in a marked patrol vehicle of FHP0475. The vehicle has an in car camera that was utilized for this investigation. I was dispatched to an incident that occurred in the interchange of Interstate 595 and US 441. There was a [REDACTED] that had apparently been stopped by a concerned citizen due to the driving being possibly impaired. I responded to the incident.

Upon my arrival, I made contact with the concerned citizen, [REDACTED]. [REDACTED] has a California License number of [REDACTED]. The concerned citizen advised me that the [REDACTED] was swerving all over the road and almost collided with his vehicle. The concerned citizen advised that the [REDACTED] then almost struck a wall. The concerned citizen advised that the vehicle then came to a stop on the road. The concerned citizen advised that he drove next to the subject and suggested for him to pull over. The concerned citizen advised that when he went to speak to the driver after the vehicle stopped on the right shoulder, the driver handed him the keys and attempted to make arrangements for a ride.

I then went to speak with the driver that was still sitting in the [REDACTED]. I approached on the passenger side window and identified myself. I then asked the driver "whats going on". The driver made conversation and advised that he was stopped by the other driver and was tired. I could immediately smell a strong odor of an unknown alcoholic beverage emitting from his facial area as he spoke. The driver's eyes were bloodshot red and glossy. The driver was requested to provide his ID. The driver issued me a Florida License that identified him as Thomas Ryba.

I requested the driver to exit the vehicle. The driver exited the vehicle. I spoke to the driver in front of my vehicle. I could still smell a strong odor of an unknown

alcoholic beverage emitting from his facial area as we spoke I requested the driver to perform field sobriety tasks in order to dispel or confirm my observations The subject questioned what would happen if he refused to perform the tasks I advised the driver that I would have to take a determination on the investigation based on the circumstances known to me I then explained the observations/circumstances known to me The driver advised that he would perform the tasks

The tasks were performed at the location The location is on a slight uphill slope A marked yellow line was utilized It was hard and paved flooring It was lit with street lights The roadway was dry and there was no inclement weather

I asked all pertinent questions of Mr Ryba Mr Ryba did not have an injuries or surgeries and did not have any glasses or contacts. The first task was the horizontal gaze nystagmus. I gave all of the instructions. During the task, Mr Ryba had a distinct circular sway Mr Ryba had to be reminded not to move his head. Mr Ryba had a distinct strong odor of an unknown alcoholic beverage emitting from his facial area that I could smell strongly from being in close proximity to him Mr. Ryba displayed all six clues

The second task was the walk and turn A straight yellow line was utilized I demonstrated and explained the entire task Mr Ryba advised he understood and had no questions Mr Ryba was allowed to perform the task twice. During the first attempt, Mr Ryba advised that he needed to urinate to perform adequately He was allowed to urinate During the first pass through, Mr Ryba took 16 steps on the first series of steps. Mr. Ryba stepped off of the line several times Mr Ryba could not maintain the starting position. During the second pass, Mr. Ryba stepped off of the line

The third task was the one leg stand. I demonstrated and explained all of the

instructions. Mr Ryba advised that he understood and had no questions During the task, Mr Ryba had a distinct and apparent sway. Mr Ryba never lifted his foot more than 6 inches from the ground, and never kept his leg straight as he was instructed

The fourth task was the finger to nose I demonstrated and explained the instructions for the task Mr Ryba advised that he understood and had no questions During the task, on the fifth prompt to lift his right arm, he lifted his left arm, then corrected it quickly and raised his right arm. Mr. Ryba could be observed to have a distinct sway during the task

The fifth task was the modified rhomberg task All instructions were given to Mr Ryba Mr Ryba advised that he understood and had no questions. During the task, Mr Ryba took 44 seconds to count 30 seconds Mr Ryba had a very distinct circular sway to him as he conducted this task

Based on the totality of the circumstances, Mr. Ryba was placed under arrest at approximately 4 53 AM Mr Ryba was read implied consent on video. At approximately 5 06 AM, Mr Ryba refused to provide a breath sample

All of the events took place in Broward County Florida.

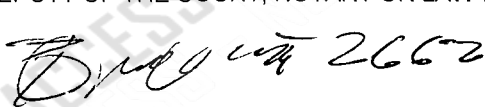
