The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/29/2022 within the City of Tampa the defendant (Thomas Joseph Buettner) did violate the listed Florida State Statutes. The defendant committed an affray by engaging, in fighting with another person in a public place to the terror of the people. The defendant was also intoxicated and endanger the safety of another person while fighting. While being taken into custody the defendant resist, obstruct, and opposed law enforcement.

Law enforcement responded to the listed incident location in reference to subjects fighting and one person needing EMS. Upon arrival the defendant was located, he showed signs of intoxication, having slurred speech, blood shot eyes, and was unable to follow lawful commands. The defendant was observed throwing a closed fist strike (punch) at another subjects face. As a result he was OC sprayed to break up the affray occurring but left the scene before he could be arrested.

While law enforcement was leaving the scene I was waived down by an unknown white male, he pointed at the defendant and stated that he was fighting again. I looked over to see the defendant being held back by another unknown male.

I then detained the male in handcuffs but he began to tense up and actively resist. He refused to cooperate with lawful commands and had to be pulled into the patrol vehicle. It should be noted that I was in an agency issued patrol uniform with badge affixed along with arriving in a marked patrol vehicle with City of Tampa insignia on all sides. The defendant was then identified via DHSMV as Thomas Buettner. He was advised of his charges and transported to the jail.
