The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On 12-04-2021 at approximately 2045 hours, your affiant observed an operator of a vessel (FL6938RP) in violation of F.S.S.327.33 (Navigation Lights Not In Use), F.S.S 328.48(5) (Improper Display of Vessel Registration), F.S.S. 327.50(1)(B) (PFD Not Worn by Child Under Six) along the Alafia River just west of the Hwy 41 S Bridge; within Hillsborough County. Your affiant conducted a vessel stop for the above stated violations and for the purposes of completing a boating safety inspection. Your affiant did not observe any boating safety inspection decal(s) affixed to the vessel. Upon stopping the vessel, your affiant made contact with the operator/defendant who was standing at the helm of the vessel and attempted to dock the vessel at the Williams Park Boat Ramp; which he had trouble doing. There was an open alcoholic beverage bottle at the helm of the vessel in plain view. During contact with the defendant, your affiant observed him to have blood shot watery eyes, slurred speech and the distinct odor of an alcoholic beverage coming from his breath. The defendant became agitated during the safety inspection and began slamming the vessels compartments while looking for the safety equipment. I observed empty alcoholic cans in the front port side compartment during the safety inspection. The defendant used the sides of the vessel to help brace himself during the safety inspection. The defendant was also unsteady on his feet and had to be reminded of my request to see a fire extinguisher. The defendant was unable to provide the required USCG Safety Equipment (Type IV Throwable Device, Fire Extinguisher and Sound Producing Device). The defendant also did not provide the vessels registration; which is required under F.S.S. 328.48(4). Your affiant requested the defendant to perform Standard Field Sobriety Tasks (SFST's) to determine if he was fit to operate the vessel. The defendant refused the SFST's. Your affiant requested the defendant to perform the SFST's multiple times and explained the reasons for such request. The defendant refused all requests of the SFST's. Based on observations of impairment, your affiant placed the defendant under arrest for BUI. The defendant was advised of Florida Implied Consent. The defendant stated he understood and refused to provide a breath sample. The child on board the vessel while it was underway at the time of the vessel stop was two years of age. The defendant was identified verbally, via DAVID and Florida DHSMV #M-520-833-87-189-0.
