The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a black 2009 Nissan Xterra, 4 door SUV, Texas tag NZW4961. The defendant drove in a manner in which the vehicle drifted onto painted lane markers several times, drifted well over painted lane markers several times, followed two other vehicles too closely, and drove at a very high rate of speed. The defendant drove at a speed up to 101 MPH in a properly posted 55 MPH speed limit (visually estimated and patrol car paced, TPD DUI unit 5055). A traffic stop was conducted for unlawful speed, as well as to check on the welfare of the defendant to determine if he was sick, tired, or impaired. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot and watery, his face was flushed, and his speech was low. The defendant stated that he drank two beers tonight. The defendant was mildly unsteady exiting the vehicle, and he swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on the totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .161% BrAC and .155% BrAC. The defendant was positively identified by his Texas DL.
