The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a red Chevy Sonic (FL GTRE47) that struck a gray Toyota Camry (FL PLXU50) when it turned in front of the Camry. During observations, the defendant displayed indicators of impairment which included having slurred speech, red glassy eyes, and the distinct odor of an alcoholic beverage on her breath. She was unsteady on her feet and leaned against the back of a silver vehicle for support. She displayed additional indicators of impairment during SFST's and was arrested for DUI. She was taken to CBT where she took the breath test. She provided breath samples of .218/.220. The defendant's identity was verified using her state of Florida driver's license.
