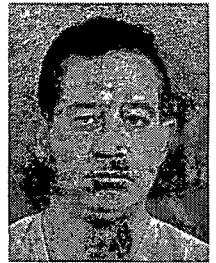

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law

On 01/31/2022, at 11 39 (Specifically include facts constituting cause for arrest)

While on routine patrol, I observed a silver in color, 4 door SUV, traveling northbound on I-75 at a high rate of speed I was stopped, facing northbound, operating stationary radar with my department issued certified stalker DSR 2x, front antenna serial# KC157190 I directed my radar unit in the direction of the vehicle and I obtained a clear, steady audio Doppler tone which correlated with my estimated speed I had clear and un obstructed view of the vehicle with no other vehicles on the road. A radar measurement of 114 mph was displayed as assigned to the vehicle I proceed to conduct a traffic on the vehicle by turning on my emergency lights, and then vehicle came to a stop

After stopping the vehicle, the driver was identified by Nevada DL as Mr Tiki Bakhshi While speaking to him, it was observed that a light odor of alcoholic beverage was coming from him.

It was observed that Mr. Bakhshi had.

- Bloodshot eyes
- Watery eyes
- Slurred speech

Mr Bakhshi reported taking medication

Before beginning the tests, Mr Bakhshi was asked if he had any medical problems and he replied that he did

Additional observations Three empty beer bottles in the back seat of the vehicle and a mug full of whiskey in the front seat .

HORIZONTAL GAZE NYSTAGMUS TEST

Prior to attempting this test, Mr Bakhshi indicated he did not have any medical problems that would have prevented him from performing the test It was determined that he was not wearing contacts His eyes were checked and they displayed equal tracking and his pupils were equal sizes Mr Bakhshi was instructed to follow the stimulus with his eyes only, keeping his head still After stating that he understood the instructions, Mr Bakhshi attempted this test

The results of this test displayed 6 of the 6 possible clues.

- A lack of smooth pursuit in the left eye
- A lack of smooth pursuit in the right eye
- A distinct and sustained nystagmus in the left eye at maximum deviation
- A distinct and sustained nystagmus in the right eye at maximum deviation
- An onset of nystagmus in the left eye prior to 45 degrees
- An onset of nystagmus in the right eye prior to 45 degrees

The test revealed the presence of vertical nystagmus

Comments Swayed and could not keep head straight

WALK AND TURN TEST

Prior to attempting this test, Mr Bakhshi indicated he did not have any medical problems that would have prevented him from performing the test Mr Bakhshi was instructed to put his left foot on the line and his right foot in front of it with his right heel touching the toe of his left foot He was instructed to stand in this manner with his hands to his sides until the test instructions were completed and the test demonstrated Mr Bakhshi was instructed not to begin the test until told to start He was instructed to take nine steps along the line in a heel-to-toe manner After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around After turning around he was to take nine steps in a heel-to-toe manner back along the line, in the direction he had come from Mr Bakhshi was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud After the test was demonstrated Mr. Bakhshi stated that he understood the instructions and was instructed to begin the test

The results of this test displayed 5 of the 8 possible clues

During the test, he stopped once while walking

On the first set of steps, he incorrectly took 15 steps instead of 9 He did not touch heel-to-toe on steps 1, 3, 4, 5, 6, 7, 8, 9 He stepped off the line on steps 1, 3, 4, 5, 6, 7, 8, 9

He turned improperly.

On the second set of steps, he incorrectly took 10 steps instead of 9 He did not touch heel-to-toe on steps 1, 2, 3, 4, 5, 6, 7, 8, 9. He didn't step off the line.

He didn't use his arms for balance.

FINGER TO NOSE TEST

Prior to attempting this test, Mr Bakhshi indicated he did not have any medical problems that would have prevented him from performing the test. <No Driver Name> was instructed to stand with his feet together during the test and start by

On 01/31/2022 , at 11 39 (Specifically include facts constituting cause for arrest)

placing his arms at his sides He was instructed not to begin the test until told to start. Mr Bakhshi was told that he will have to tilt his head back slightly and close his eyes He will then have to touch the tip of his nose with the index finger (left or right as indicated) and return to start position He was further instructed to keep his eyes closed during the entire duration of the test After the test was demonstrated Mr Bakhshi stated that he understood the instructions and was asked to begin the test. During the test, Mr Bakhshi was asked to touch his nose 6 times in the following order left, right, left, right, right, left He was swaying during the test He moved his head during the test
Comments Swaying and did not follow directions

MIRANDA WARNINGS

<Ofc N Rodriguez read the Miranda rights to Mr Bakhshi at 12 08 PM on the January 31, 2022.
The rights were read in English.

To the question, "Do you understand the explained rights?", Mr Bakhshi replied yes with a verbal "Yes"

To the question, "Do you wish to talk to us?", Mr Bakhshi replied no

Mr Bakhshi was placed into custody for DUI and transported to Broward County Jail
