

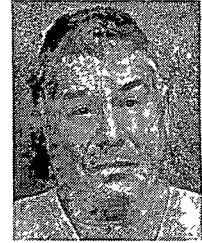

Probable Cause Affidavit

Before me this date personally appeared VALDEZ DIONNE (18424) who being first duly sworn deposes and says that on 9 day of February, (year) 2022 at 4491 STIRLING RD DANIA BEACH FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I observed 3 small closed bottles of vodka in the front of the vehicle. 2 bottles were in a bag and the third bottle was in the center console I attempted to interview Fernandez about the front-end damage Fernandez advised he could not remember what he hit not where it happened Fernandez had slurred speech and a strong odor of alcohol emitting from his breath I also observed Fernandez swaying while standing, he had a hard time walking I advised Fernandez that I will be conducting a DUI investigation. I asked Fernandez to submit to a roadside test and he declined Fernandez also declined to provide a blood, urine and breath test to determine his blood alcohol level Fernandez was read the Florida implied consent Law and declined all tests. Fernandez was arrested and transported to BSO main jail for processing The vehicle was towed to Max towing for storage Pictures were taken of the unopened bottles

It should be known that Fernandez does has a prior suspension for DUI refusal.
