The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/18/2022 at 2227 hours, I, Trooper Snyder, A. 1754/4958, responded to a motor vehicle collision with property damage located at SR-93 (I-275) NB just west of MacDill Ave. On arrival, I spoke with Fire Rescue who stated the Defendant, Ms. Tonya Margarite Gardner DOB: 09/03/1969, was walking along northbound I-275 away from the crash scene until they stopped her and advised that she needed to return to the scene and await law enforcement. I spoke with the driver, Mr. Gene Kelly, of Vehicle 2 (Audi Q7) who stated he observed the Defendant driving in circles backwards on the interstate for unknown reasons that ultimately caused damage to his Audi Q7. I spoke with the Defendant and before she spoke immediately smelled alcoholic beverage coming from her direction and was even more apparent when she spoke. I asked the Defendant what caused the collision and she was unable to provide a clear answer. As she spoke, her words were slurred and thick tongued; she appeared confused and disoriented. The defendant struggled to balance and I observed her swaying forward and backwards. When taking her into custody, she was unable to balance without assistance from me and fire rescue who remained on scene until The defendants face was flushed and her eyes were bloodshot, glassy, and watery. I advised the defendant of her Miranda rights and asked her to perform Standardized Field Sobriety Exercises (SFSE's) in which she declined. The defendant was was arrested and charged with Driving Under the Influence with Property Damage (F.S. 316.193(3)(c)1 (Misd) and transported to the Hillsborough County Jail on Orient Rd without incident. The defendant was read Implied Consent and gave consent to provide a breath sample; her results were: Sample #1: 0.237 Sample#2: 0.233 Nothing further.
