Jackson (94905) conducted a traffic stop on a silver Hyundai Elantra (FL: 0243YG) after observing the vehicle drive past the stop bar and almost causing an accident. Upon contact with the defendant, indicators of impairment were observed which included bloodshot glassy eyes, slurred speech, and the odor of an alcoholic beverage emitting from her breath.
