The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a blue Toyota pickup bearing FL tag HCRU56. The defendant was observed appearing intoxicated as he was in his vehicle in the parking garage after a Tampa Bay Lightning game, causing a concerned citizen to call for police services (22-210754). Ofc. Martin located the vehicle traveling southbound on Bayshore Bv from Brorein St. The vehicle continually drove in and through the bicycle lane and struck several raised plastic lane divider warning markers. Upon traffic stop, the defendant exhibited indicators of impairment to include confusion, lethargy, ptosis, a dazed appearance, the overwhelming odor of an alcoholic beverage emanating from his breath, slurred speech, and unsteadiness on his feet. The defendant attempted to re-enter the vehicle when asked to participate in SFSE's and was arrested for DUI. The defendant refused to provide a breath sample after being advised Implied Consent. The defendant was ID'ed via FL DL.
