The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/17/2022, near the intersection of East Bloomingdale Avenue and Bryan Road, Brandon, Florida 33511 Deputy W. Barnes ABN: 242424 observed the defendant in physical control and operating a black 2015 Chevrolet Pick up bearing Florida tag DYRU01 with an assigned VIN of 1GCGSBE36F1130830 failing to maintain a single lane and effecting a general flow of traffic. Upon Deputy Barnes' contact with the defendant, he observed multiple indicators of impairment. While in direct contact with the defendant, I observed him to have bloodshot watery/glassy eyes, he had slurred speech, he was slightly unsteady on his feet and I smelled the strong odor of an alcoholic beverage emitting from his breath. The defendant participated in the field sobriety exercises, and while doing so, he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration he was placed under arrest for DUI. The defendant was transported to Central Breath Testing and he refused to provide two lawful breath samples. The defendant was read Implied Consent and he continued to refuse "No, I am not taking the test." I further identified the defendant via his DAVID photograph.
