The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01-14-2022, at 2322 hours, Deputy Graham #258662 was northbound on S U.S. Highway 41, heading toward Riverview Drive when a black Mercedes E350 bearing FI tag QSWL66 (VIN WDBUF56X17B127144) passed him also heading northbound. Deputy Graham noticed the vehicle had an expired license plate (11-28-21) and observed the vehicle weaving outside its lane. Deputy Graham conducted a traffic stop on the vehicle and upon making contact with the driver (defendant), observed her displaying indicators of impairment. I observed the defendant displaying glassy eyes, slurred speech, was unsteady on her feet and I detected the odor of an alcoholic beverage emanating from her breath. The defendant performed field sobriety exercises and impairment was detected. The defendant provided two lawful samples of breath, (.216) and (.208) after a twenty minute observation period. The defendant was identified via her Florida drivers license.
