Before me this date personally appeared _____ who being first duly sworn deposes and says that on
19 day of November, (year) 2021 at 3691 TURTLE RUN BLVD, CORAL SPRINGS, FL 33067 (crime location)
the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

BUICK WAS TRYING TO TAILGATE HIM THROUGH THE SECURITY GATE.

I MADE CONTACT WITH THE DRIVER OF THE BUICK, WENDI WIETSMA (W/F DOB 01/24/73), AT THE DRIVERS SIDE WINDOW. THE VEHICLE WAS RUNNING AND WIETSMA HAD PHYSICAL CONTROL OF THE VEHICLE. UPON MAKING CONTACT WITH WIETSMA I COULD SMELL THE ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE EMANATING FROM HER PERSON. I ALSO OBSERVED THAT WIETSMA HAD WATERY BLOODSHOT EYES AND HAD SLURRED SPEECH. I ASKED WIETSMA IF SHE NEEDED ANY MEDICAL ATTENTION FOR THE AUTO ACCIDENT TO WHICH SHE ASKED "I WAS IN AN ACCIDENT?". WIETSMA STATED THAT SHE WAS NEVER IN AN ACCIDENT AND REFUSED MEDICALLY TREATMENT ON SCENE.

I ASKED WIETSMA TO STEP OUT OF THE VEHICLE TO WHICH SHE COMPLIED. UPON EXITING HER VEHICLE I OBSERVED THAT WIETSMA WAS HAVING TROUBLE BALANCING AS SHE WALKED AND STOOD. WIETSMA HAD TO USE HER VEHICLE TO BALANCE. I ASKED WIETSMA IF SHE REMEMBERED ANYTHING RELATED TO THE ACCIDENT TO WHICH SHE STATED "I'M ALMOST HOME". I ASKED WIETSMA IF SHE HAD DRANK ANY ALCOHOLIC BEVERAGES TO WHICH SHE STATED YES. OFFICER S. CLARKE ARRIVED ON SCENE AND TOOK OVER AND COMPLETED THE ACCIDENT INVESTIGATION PRIOR TO MY DUI INVESTIGATION.

I INFORMED WIETSMA THAT I BELIEVED SHE WAS DRIVING UNDER THE INFLUENCE OF ALCOHOL. I REQUESTED WIETSMA TO SUBMIT TO SOME VOLUNTARY ROADSIDE SOBRIETY EXERCISES TO TRY TO DISPEL MY BELIEF THAT SHE MAY BE UNDER THE INFLUENCE OF ALCOHOL TO THE EXTENT THAT HER NORMAL FACULTIES WERE IMPAIRED. WIETSMA ADVISED SHE WOULD NOT PERFORM THE EXERCISES AND AGAIN STATED, "I'M ALMOST HOME". WIETSMA ADVISED SHE IS NOT CURRENTLY UNDER A DOCTOR'S CARE AND NOT TAKING ANY MEDICATIONS AT THIS TIME. I ASKED WIETSMA IF SHE WOULD PROVIDE A SAMPLE OF HER BREATH TO DETERMINE ITS ALCOHOLIC CONTENT TO WHICH SHE STATED, YES. WHEN

Before me this date personally appeared _____ who being first duly sworn deposes and says that on 19 day of November, (year) 2021 at 3691 TURTLE RUN BLVD, CORAL SPRINGS, FL 33067 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

I ATTEMPTED TO ASK WIETSMA FOLLOW-UP QUESTIONS, SHE TOLD ME "GO FUCK YOURSELF".

BASED ON MY OBSERVATIONS, I BELIEVED THAT WIETSMA WAS DRIVING UNDER THE INFLUENCE OF ALCOHOL AND PLACED HER INTO HANDCUFFS AND PLACED HER IN THE REAR OF MY PATROL VEHICLE. I TRANSPORTED WIETSMA TO CSPD BOOKING. I ASKED WIETSMA IF SHE WAS WOULD PERFORM SFST'S AND PROVIDE A BREATH SAMPLE. OFFICER WAYE, OFFICER BROADHURST, AND OFFICER DADDINO ARRIVED AT THE BOOKING ROOM AND ASSISTED ME TO BRING WIETSMA TO THE DUI ROOM. ONCE IN THE DUI ROOM WIETSMA PERFORMED THE FOLLOWING EXERCISES:

WALK AND TURN: COULD NOT KEEP BALANCE AND ATTEMPTED TO START TOO SOON MULTIPLE TIMES. I HAD TO EXPLAIN TO WIETSMA TO NOT START UNTIL INSTRUCTED TO REPEATEDLY. MISSED HEEL TO TOE THROUGHOUT THE EXERCISE. RAISED ARMS TO BALANCE. TOOK 13 STEPS OUT AND 13 STEPS RETURNING. DID NOT COMPLETE THE TURN AS INSTRUCTED, DID A TWIRL TO MAKE THE TURN.

ONE LEG STAND: ATTEMPTED THE EXERCISE BEFORE I INSTRUCTED HER TO DO SO. USED ARMS TO BALANCE AND DID NOT COUNT AS INSTRUCTED AND COUNTED 1-1000, 2-000. ALMOST FELL WHILE PERFORMING AND HAD TO CATCH HERSELF USING THE WALL. I TERMINATED THE EXERCISE AFTER THAT.

I INSTRUCTED WIETSMA THAT THE EXERCISE WAS TERMINATED AND ASKED IF SHE WOULD LIKE TO CONTINUE WITH THE SFTS TO WHICH SHE WAS VERBALLY AGGRESSIVE YELLING "FUCK YOU" AND FLICKED ME OFF. I ASKED WIETSMA IF SHE WOULD PROVIDE A BREATH SAMPLE TO WHICH SHE CONTINUED TO CUSS AT ME AS I ATTEMPTED TO READ HER IMPLIED CONSENT AND BECAME PHYSICALLY AGGRESSIVE AND ATTEMPTED TO GRAB AT ME. UPON GRABBING AT ME I ATTEMPTED TO RESTRAIN WIETSMA WITH THE HELP OF OFFICER WAYE. WIETSMA BEGAN TO BRACE AND TENSE HER ARMS AS WE

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

ATTEMPTED TO PLACE HANDCUFFS ON HER. DURING WHICH TIME WIETSMA INTENTIONALLY KICKED ME IN THE LOWER HALF OF MY LEFT LEG. WE WERE ABLE TO PLACE WIETSMA INTO HANDCUFFS AS SHE CONTINUED TO PULL AWAY AS WE DIRECTED HER TO A JAIL CELL. DUE TO WIETSMA BEING COMBATIVE, WE PLACED HER INTO THE RESTRAINT CHAIR AND SHE WAS PLACED INTO A CELL. I WAS ABLE TO ASSESS MYSELF FOR INJURIES AND DID NOT OBSERVE ANY ON MY LEG.

DUE TO HAVING TO RESTRAIN WIETSMA, I WAS UNABLE TO READ IMPLIED CONSENT COMPLETELY. APPROXIMATELY 3 HOURS LATER WIETSMA WAS CALM AND WILLING TO PROVIDE A BREATH SAMPLE. THE CSPD BREATHALYZER 8000 WAS HAVING TECHNICAL DIFFICULTIES AND WAS NO LONGER OPERATIONAL. AT WHICH TIME I MADE CONTACT WITH COCONUT CREEK PD AND WAS ADVISED THEY HAD AN OPERATIONAL BREATHALYZER 8000. I TRANSPORTED WIETSMA TO THE COCONUT CREEK PD AND MADE CONTACT WITH OFFICER FEISTHAMMEL (ID 18652), WHO IS A CERTIFIED BREATH TEST OPERATOR. OFFICER FEISTHAMMEL WAS ABLE TO SECURE TWO BREATH SAMPLES FROM WIETSMA WHICH READ .147 FOR THE 1ST ATTEMPT AND .147 FOR THE SECOND ATTEMPT. SEE OFFICER FEISTHAMMEL'S AGENCY INCIDENT REPORT (#2021-32182) FOR FURTHER INFORMATION.

BASED ON THE ABOVE, I CHARGED WIETSMA WITH DUI 1ST OFFENSE PURSUANT TO F.S.S 316.193(2)(A)(2)(A) AND BATTERY ON A LAW ENFORCEMENT OFFICER PURSUANT TO F.S.S 784.07(2)(B). I CITED WIETSMA FOR DUI FIRST OFFENSE WITH CITATION # ACEVSJE. DUE TO THE LACK OF INJURIES FROM THE CRASH WIETSMA WAS NOT ISSUED FURTHER CITATIONS AT THIS TIME IN ACCORDANCE WITH CSPD POLICY. WIETSMA WAS LATER TURNED OVER TO BSO.

THIS INCIDENT WAS CAPTURED ON MY BODY-WORN CAMERA THAT WAS DOWNLOADED AT CSPD UPON COMPLETION OF MY INVESTIGATION.
