The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/19/2022 at approximately 0053 hours, TPD Cpl. A. Morejon located the driver/defendant asleep in the drivers seat of a running 2018 gray Subaru Forester with New Mexico tag AYT837 on the side of the road just south of the intersection of 34th St N and Adamo Dr which was observed to be in "drive". He made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted. I responded to the scene and observed the driver/defendant seated in the drivers seat of the vehicle vomiting out the driver side window. I made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, droopy eyelids, a flushed complexion, he had the odor of an alcoholic beverage coming from his breath, and was unsteady on his feet. He confirmed he had been drinking in Ybor prior to driving. Due to his level of intoxication and his unsteadiness on his feet he was unable to participate in SFSTs and was arrested for DUI. The defendant submitted to the requested breath testing which produced a BrAC of 0.138/0.129. The defendant was positively identified via New Mexico drivers license.
