The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/17/2022 at approximately 1911hrs, affiant conducted a vessel stop on a white/blue 24' Sea Fox boat bearing FL0210RP/Hin:LYGPB103H718 on the Alafia river just west of South Us Highway 41 Riverview, Hillsborough County, FL 33578 for a posted Idle speed violation (citation:V659547). Upon stopping the boat, affiant made contact with the operator / defendant, who was standing at the helm of the boat behind the steering wheel. During personal contact with the defendant, affiant detected a strong odor of an alcoholic beverage coming from his breath, observed him to have blood shot watery eyes and noticed he spoke with a slurred speech. Based on this, affiant requested the defendant perform seated standardized field sobriety tasks to determine if he was operating a his boat while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the SFSTs. Based on observations of impairment, the defendant was arrested for BUI and secured in handcuffs. The defendant was transported to Central Breath Testing located within the Orient Road Jail. Upon arrival, affiant advised the defendant of Florida Implied Consent (2023hrs). The defendant stated he would submit to the test. After a 20 minute face to face observation period the defendant was given the opportunity to provide a breath sample. The defendant was seated next to the instrument and stated "I'm not taking the test". The defendant was then advised Florida Implied Consent again (2049hrs). The defendant advised he understood and refused to provide a breath sample. The defendant was identified by a Michigan drivers license and verbally id himself.
