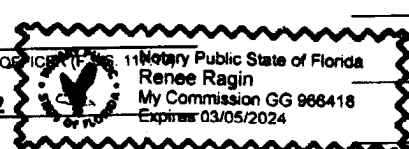

On 05/28/2022 at approximately 2337 hours, this Officer arrived in the area of Alt A1A just south of Donald Ross Rd, PBG, FL, to assist Ofc Jung 454 with a traffic stop. Body worn camera and in car video were used. Ofc Jung said he observed the vehicle, a Lexus utility traveling 67 MPH in a posted 50 MPH zone, in the 13000-block of Alt A1A, PBG, FL. This Officer made contact with the driver, identified via Florida Driver License photo, William Falconio (OF) while he was still in actual physical control of same. Falconio had red watery eyes, thick slurred speech, flushed red face and the obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Falconio said he was coming from "Voodoo Bayou". When asked how much he had to drink tonight, Falconio replied "not much just a couple drinks". Based on this Officer's observations, Falconio was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. Falconio said he did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Falconio also had the onset of Nystagmus in both eyes, prior to 45 degrees and Vertical Gaze Nystagmus in both eyes. Falconio was swaying back and forth during the exercise. The second exercise conducted, was the Walk and Turn. The line used, was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Falconio was swaying side-to-side and was rotating his lead foot up and down while trying to maintain balance. During the first set of steps, Falconio stepped off the line on the ninth step and went then went into the turnaround. Falconio conducted an improper

turnaround, by way of removing his lead foot from the line. Falconio then asked for further instructions before continuing. The third exercise conducted, was the One-Leg Stand. During the exercise, Falconio raised his left foot. Falconio swayed and raised his arms more than six inches from his sides. Based on this Officer's observations, Falconio was placed under arrest at 2345 hours. On the roadside, this Officer requested Falconio to provide a breath sample for the purpose of determining its alcohol content, to which he requested his rights regarding the request. This Officer read updated Florida Implied Consent to Falconio to which he acknowledged and agreed to provide a breath sample. This Officer transported Falconio to PBSO BAT and again requested him to provide a breath sample, to which he refused. This Officer read updated Florida Implied Consent to Falconio to which he acknowledged and again refused at 0041 hours. Based on the results of the investigation and the totality of the circumstances, this Officer has probable cause to prove William Falconio operated a motor vehicle, in the state of Florida, while under the influence to the extent his normal faculties were impaired, in violation of FSS 316.193(1) (A).
