Officer Culver utilized his department issued Axon 3 body worn camera during the following incident: On Friday, March 25, 2022, at approximately 11:25 a.m., Officer Culver was dispatched to the business of Carswell Landscaping located at 48 West 23rd Street, Riviera Beach, Florida 33404, in reference to a delayed theft. Officer Culver met with the reporting party and business owner Steven W. Carswell (W/M 01/13/1966), who will be referred to as (RP) hereinafter. The (RP) provided Officer Culver with the following information: On Wednesday, March 23rd, 2022, two employees of the company contacted the (RP) and informed him of their resignation from the business effective immediately. The two employees are identified as Wyatt P. Richardson (W/M 12/09/1995), who will be referred to as suspect 1 (S1) hereinafter, _____ who will be referred to as suspect 2 (S2) hereinafter. On the above mentioned date, between the hours of 8:30 a.m., and 9:00 a.m., both (S1) and (S2) are captured on the businesses security cameras removing multiple plants from the property before turning in their company keys and credit cards. The stolen plants are taken out to the suspect's vehicles, which are parked in front of the business. (S1) appears to be operating a black in color Ford pickup truck. It should be noted (S1) has a 2019 black in color Ford, bearing Florida tag #III14QR registered to him. (S2) appears to be operating a gray in color Dodge SUV. It should be noted that (S2) has a 2015 gray Dodge bearing Florida tag #GJTK78 registered to her. Both parties place the stolen items into both vehicles, and leave the area traveling in different directions. (S1) travels East on West 23rd Street towards Broadway at approximately 8:51 a.m., and (S2) travels west on West 23rd towards Avenue E. As (S1) is traveling eastbound away from the business, you can clearly see an abundance of plants in the vehicle's truck bed. The (RP) is unable to clearly identify the exact type of

	plants, or their values. However; one of the plants captured on video being removed from the property by (S2), is identified as a pink princess and is worth approximately \$1,500 in U.S currency. The (RP) provided Officer Culver with the contact information for both suspects that was provided to the company for hiring purposes, to include their current cell phone numbers. Officer Culver made several attempts to reach both parties via landline, but was met with negative results. The (RP) was unable to provide a physical copy of the security footage due to system complications, but stated he would provide it at a later date and time to be uploaded to evidence.com for court purposes. The (RP) did verbally state he wishes to press charges and prosecute for the theft. Upon receipt of the security footage, charges are pending for both (S1) and (S2) for the offense of grand theft. This is an ongoing investigation. On Wednesday, March 30, 2022, Officer Culver responded back to the business and made contact with the victim, who provided the security video which captured the incident. The victim also provided Officer Culver with additional information. On March 21st, 2022, at 11:09 a.m., the victim's company credit was used to purchase (30) units of "Black Mondo" plants, from A.R.M International Corp., for a total of \$149.51 in U.S currency. (S1) then planted the purchased items at one of the company's clients properties, and instructed the client to pay with a check made out to (S1)'s business Meristem Horticultural Services, instead of Carswell Landscape. The victim provided a banking statement showing the transaction for \$149.51, and an invoice from (S1)'s business given to the client showing an amount owed for the items purchased using Carswell Landscaping's company credit card. Based on the conclusion of Officer Culver's investigation, a warrant for the arrests of Wyatt Richardson, [REDACTED] are being requested for the offense of Grand Theft.
