 On 11/15/2021 at 2310 hours, I responded to 10123 Courtney Palms Blvd Tampa, FL 33619 in reference to a domestic disturbance. While enroute to the scene, I was advised by dispatch that a female had stabbed the male complainant. Upon my arrival, I made contact with the victim, Dominic Cabey who had been stabbed on the right side of his neck. Dominic stated the following information under oath. His wife, Yana Nikolaeva and he got into a verbal argument over signing divorce paperwork. He went into their shared bedroom and was in the bed. While in the bed Yana battered him by striking him in the face causing his nose and lip to bleed. He responded to their bathroom which is connected to their bedroom, Yana came inside the bathroom and stabbed him with a knife on the right side of his neck. Dominic and Yana have been married for approximately three years and have a three year old child in common. Yana was positively identified via her Florida Driver's License.
