<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On 07/06/2022, at approximately 2341 hours, located at 1306 High Hammock Dr. - Apt 204 the defendant consumed an unknown amount of an alcoholic beverage which engaged a verbal argument between the victim and the defendant. The defendant for an unknown reason, acted in an irate and belligerent manner towards the victim. The victim removed herself from the situation by sitting on the balcony of the apartment. The defendant knowingly and intentionally, slapped the victim with an open hand once, across the left side of the victim's face. Subsequently after the victim was struck against her will, the defendant knowingly and intentionally, grabbed the victim with his hand, on the neck area for approximately five seconds.
