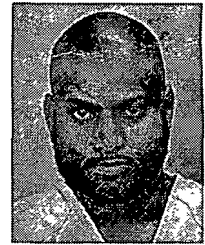

Probable Cause Affidavit

Before me this date personally appeared HALLER, CARL W. (3733) who being first duly sworn deposes and says that on 2 day of September, (year) 2017 at 8399 W OAKLAND PARK BLVD, SUNRISE, FL 33351 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On September 02, 2017 at approximately 04:10 hours I was dispatched to 8399 W Oakland Park BLVD in the City of Sunrise, Broward County, Florida in reference to a traffic crash. I was first to arrive on scene at which point I met with the reporting party and witness, Eulis Head (W). Eulis stated he witnessed the defendant, later identified as Yashpal Sobaram, as the sole occupant of a gold BMW bearing FL tag #J300IH (V1) put his vehicle reverse in the parking lot of Cheers (Bar). He then proceeded to back up at which point his rear passenger side bumper impacted with the passenger side wheel well of a red Toyota Tacoma bearing FL #130YLW (V2) that was just North of the Defendants vehicle at approximately 5 MPH. The Tacoma's owner was not in the vehicle at the time of the crash.

I identified myself as a Sunrise Police Officer and requested both vehicle owner's to provide their Driver's license, vehicle registration and proof of insurance. As I gathered the documents from the defendant I observed slurred speech, bloodshot watery eyes, and a strong odor of alcohol emanating from the defendant's breath as he spoke. The defendant was bracing himself on the vehicle to keep upright and continue to ramble on about nonsense. I asked if he needed medical attention to which he refused. It took several minutes for the defendant to gain the ability to operate his cellular phone in order to produce a copy of his insurance. The defendant was identified from FL DL as Yashpal Sobaram.

From the witness statement and the physical evidence on both vehicles I determined that the defendant of V1 had backed into V2 and concluded my traffic crash report. I instructed the defendant that I was now beginning a criminal DUI Investigation and read

(3733) who being first duly sworn deposes and says that on 2 day of September, (year) 2017 at 8399 W OAKLAND PARK BLVD, SUNRISE, FL 33351 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

him his Miranda Warning from prepared card. The defendant verbally acknowledged understanding and stated he does not have any medical problems or physical defects/disabilities. He stated he is not sick/ injured, nor take any drugs/ medication, or have epilepsy/diabetes. He stated he does not have any problems with his eyes and that he doesn't wear glasses or contacts.

I requested the defendant do a voluntary roadside field sobriety test to which he accepted. The defendant was dressed in closed toed shoes, jeans and a t-shirt. I led the defendant to a well-lit area with a straight line. As the defendant walked to the area of the parking lot approximately 15 feet to the rear of his vehicle he swayed several times and had difficulty standing upright.

The following exercises were demonstrated clearly and concisely to the defendant. He verbally acknowledged understanding and agreed to perform them by stating "I'm drinking, but I'll do them. I observed the following:

HORIZONTAL GAZE NYSTAGMUS:

Unable to complete test
Moved head side to side
Swaying during testing
Instruction had to be repeated

WALK AND TURN:

Unable to complete test
Can't keep balance while listening to instructions (failed to maintain instructional

Based on the defendant's performance of the exercises he completed and other observed factors, I determined that I had probable cause to arrest the defendant. I placed the defendant under arrest for DUI, handcuffed (double-locked) the defendant. The defendant was searched and placed into my patrol vehicle. The defendant was then transported to the Broward Sheriff's Office BAT (Breath Alcohol Testing) unit located at 200 NW 27th Avenue, Fort Lauderdale, Broward County, Florida. While enroute, the defendant stated he had drunk 4 beers prior to operating his motor vehicle and did not believe he was impaired.

Upon arrival at the BAT, the defendant urinated on himself in the rear of my patrol car without requesting the use of a bathroom or alerting to me the need to urinate. The
