

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On September 02, 2017 at approximately 04:10 hours I was dispatched to 8399 W Oakland Park BLVD in the City of Sunrise, Broward County, Florida in reference to a traffic crash. I was first to arrive on scene at which point I met with the reporting party and witness, Eulis Head (W). Eulis stated he witnessed the defendant, later identified as Yashpal Sobaram, as the sole occupant of a gold BMW bearing FL tag #J300IH (V1) put his vehicle reverse in the parking lot of Cheers (Bar). He then proceeded to back up at which point his rear passenger side bumper impacted with the passenger side wheel well of a red Toyota Tacoma bearing FL #130YLW (V2) that was just North of the Defendants vehicle at approximately 5 MPH. The Tacoma's owner was not in the vehicle at the time of the crash.

I identified myself as a Sunrise Police Officer and requested both vehicle owner's to provide their Driver's license, vehicle registration and proof of insurance. As I gathered the documents from the defendant I observed slurred speech, bloodshot watery eyes, and a strong odor of alcohol emanating from the defendant's breath as he spoke. The defendant was bracing himself on the vehicle to keep upright and continue to ramble on about nonsense. I asked if he needed medical attention to which he refused. It took several minutes for the defendant to gain the ability to operate his cellular phone in order to produce a copy of his insurance. The defendant was identified from FL DL as Yashpal Sobaram.

From the witness statement and the physical evidence on both vehicles I determined that the defendant of V1 had backed into V2 and concluded my traffic crash report. I instructed the defendant that I was now beginning a criminal DUI Investigation and read

At the BAT the defendant refused to take a breath test after being read Florida Implied Consent and requested to speak to an attorney. At the BAT while the defendant was alone in the holding cell he removed his pants and urinated on the floor. Due to the urine on the floor the defendant slipped in the holding cell sustaining a bloody nose and a gash on his inner lip. Upon hearing that he will need to be medical cleared before being transported to BSO Main Jail he stated "Good, that's what I wanted". He was transported to Broward General Hospital for clearance and ultimately to BSO Main Jail for processing.
