The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a gray 2020 Nissan Kicks, 4 door SUV, Florida tag 74AGCX. The defendant drove in a manner in which the vehicle was weaving from side to side within the travel lane, drifted to one side or the the other of the lane, and the left and right side tires crossed onto and over painted lane markers several times. A second vehicle pulled in behind the defendant's vehicle in a manner to indicate that driver was following the defendant and drove close enough to the defendant's vehicle as if attempting to conceal her driving motions. A traffic stop was conducted to check on the welfare of the driver to determine if she were sick, tired, or impaired. The defendant was slow to respond to the signal given to stop, and when she did stop she entered the left paved shoulder of the roadway and angled the vehicle to the right so that the front right side tire was on top of the yellow painted lane line causing the front bumper of the vehicle to protrude into the travel lane. The defendant wore a yellow paper bar band on her right wrist. The defendant had a distinct odor of an alcoholic beverage on her breath, and her face was flushed. The defendant's eyes were bloodshot, glassy, and watery. The defendant was very evasive when questioned about alcohol consumption and provided answers that were grossly inconsistent with the question being asked. The defendant eventually stated that she drank two alcoholic drinks after a male subject on her cell phone provided that answer via speaker. The defendant displayed cognitive issues as related to requested documents. The defendant was unsteady exiting the vehicle, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant provided breath samples of .159% BrAC and .160% BrAC. The defendant was positively identified by her Florida DL.
