<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>On 07/10/2022 at approximately 0313 hours, a traffic stop was conducted on a green 2007 Hyundai sedan with Florida tag BB58AC on I-275 just north of the Sligh Av northbound on-ramp after the vehicle was observed running a solid red traffic signal eastbound on Sligh Av E at the underpass with I-275. Contact was made with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, the odor of an alcoholic beverage coming from her breath, had a noticeable sway while standing, and she confirmed she had been drinking prior to driving at a family party. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. The vehicle was occupied by the defendants/drivers two children who were both under the age of 18.</p> <p>The defendant submitted to the requested breath testing which produced a BrAC of 0.150/0.147.</p> <p>A DAVID check of the defendant revealed that she has never been issued a drivers license. The defendant was positively identified via a DHSMV photograph.</p>
