The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed a red sedan pull into the gas station at US 41 and Causeway Boulevard while on another traffic stop. I observed the vehicle brake abruptly as well as park crooked in the parking spot. Another citizen approached the deputy that was with me and stated that they had seen her driving all over the road prior to pulling in. While still on the traffic stop the deputy followed her as she left the gas station and observed her failing to maintain a lane and pulling into an abandoned gas station saying that it was a 7/11. I arrived shortly after and approached the vehicle. I identified her by name and date of birth in FCIC/NCIC and permanent resident card. I could smell the odor of an alcoholic beverage coming from her mouth and could see that her eyes were bloodshot and watery. She was swaying back and forth and exhibited 4 out of the 6 clues for HGN. She also showed 5 out of 8 clues on the walk and turn, to include wrong number of steps, stopping, not touching heel to toe, using arms for balance, and improper turn. She also showed 3 out of 4 on the one leg stand to include using arms for balance, putting foot down, and swaying while balancing. She refused to give a breath sample as implied consent was read at approximately 4:17 AM. All of these events occurred in Hillsborough County, FL.
