

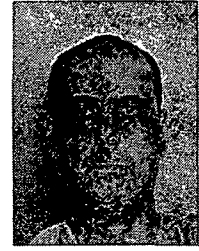

Probable Cause Affidavit

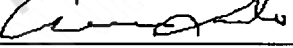
Before me this date personally appeared **DELGADO, ALBERTO (LH305)** who being first duly sworn deposes and says that on **25** day of **January**, (year) **2022** at **7484 NW 33RD ST, LAUDERHILL, FL 33319** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

The victim stated that the defendant became upset with the way she was dressed. The altercation escalated when the defendant willfully and intentionally grabbed the victim by the throat and pushed her into the bedroom against her will. The defendant then pushed the victim onto the bed and struck her twice in the face with an open hand causing a minor laceration to her upper lip. Both parties continued to struggle on the bed until their son asked them to stop.

Both parties are domestically related by a child in common and have been living together as a family for the last sixteen years. The victim's injuries were documented with a department issued body cam and she also provided a sworn taped statement. The victim does not wish to prosecute the defendant in this case.

The defendant was taken into custody without incident and he was transported to the Lauderhill Police Department reference processing and subsequently transported to The BSO Main Jail reference booking

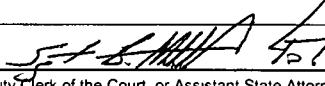
