The altercation escalated when the defendant willfully and intentionally grabbed the victim by the throat and pushed her into the bedroom against her will. The defendant then pushed the victim onto the bed and struck her twice in the face with an open hand causing a minor laceration to her upper lip. Both parties continued to struggle on the bed until their son asked them to stop. Both parties are domestically related by a child in common and have been living together as a family for the last sixteen years. The victim's injuries were documented with a department issued body cam and she also provided a sworn taped statement. The victim does not wish to prosecute the defendant in this case.
