The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On the listed date and time, the defendant was walking his dog eastbound along 112th Av E when he observed a tan pit bull near the roadway in front of the unfenced portion of the yard of the residence located at the intersection of 112th Av E and 27th St N. The dog began growling at the defendant and his dog at which time the defendant picked up his dog and returned to his residence. The tan dog did not pursue the defendant as he left the area. Upon the defendant returning to his home, he armed himself with a Smith and Wesson 9mm handgun and returned to the area where he last saw the dog. The defendant approached the dog and attempted to get the dog to return to its owner's residence at 11103 N 27th St. The dog went to the area in front of its owner's residence. While the dog was standing in front of its owner's residence, the defendant willfully/knowingly discharged his firearm on the right of way of a paved public road (27th St N) in a residential area with the intent to shoot the dog. The defendant willfully/intentionally shot the pitbull "Sugar Momma" in the neck causing excessive infliction of unnecessary pain and suffering to the animal. The defendant then left the scene and returned to his residence.

Post Miranda the defendant admitted to shooting the dog because he "wanted to protect the community".

Ofc. B. Krygier observed residential security footage in which the dog was not seen attacking or aggressively approaching the defendant when he returned to confront the dog.
