Probable Cause

On Saturday November 6, 2021 at approximately 3:27 p.m. I responded with Trooper Chinchilla to the area of Interstate 595 westbound and the SR - 91 Turnpike in reference to a group of approximately 200 motorcycles conducting an Interstate shutdown, brake checking, not letting vehicles by, and doing tricks in the roadway. The vehicles were later reported to be traveling westbound on Interstate 595. I located the vehicles westbound on Interstate 595 at Flamingo Road and turned around. I observed numerous motorcycles across all lanes and the emergency lanes. They had traffic blocked and slowed to approximately 40-50mph while they conducted the illegal shutdown and reckless driving. Some of the participants were observed wearing firearm apparel, loose fitting clothing, and shirts with numbers on the back like for a gang or group.

A traffic crash occurred between two of the participants. One of the driver's drove off with his motorcycle. The second driver fled the scene jumping on the back of a separate motorcycle leaving his behind. Trooper Chinchilla and I stopped for this crash and abandoned motorcycle as multiple motorcycles traveled recklessly to the sides and one between our vehicles.

I observed the defendant, traveling with the motorcycle group, lay her motorcycle down and crash in the middle of the Interstate. I saw the defendant go down and it appeared to be a single vehicle crash. I initially observed the defendant reaching down at the motorcycle with unknown intentions. I then observed the defendant trying to raise the motorcycle up and flee the scene. I ran towards the defendant and brought her to the ground. The defendant actively resisted, acted erratically, and attempted to pull her hands away as I attempted to detain her in handcuffs. I ordered the defendant to "stop resisting" multiple times. Once detained I walked the defendant over to Trooper Chinchilla's patrol vehicle which had been relocated to the inside emergency lane as the defendant continued to actively resist and pull away. The defendant continued to struggle at the rear of the patrol vehicle before turning around and conducting a direct knee strike to my groin area. The defendant was taken to the ground and placed in the recovery position as I attempted to catch my breath. The defendant was then stood up and placed in an FHP patrol vehicle upon the arrival of additional units.

Trooper Lopez conducted the traffic crash investigation portion of this incident. Trooper Lopez advised the defendant stated another motorcycle hit her resulting in the traffic crash. The defendant was identified by her Florida driver's license as Zoltana G. Zuhasz.

Trooper R. Hernandez transported the defendant to the Broward County Jail for booking.

All of the above events occurred in Broward County, Florida.
