The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On March 31, 2022, at approximately 0350 hours, Deputy S: Davidson (ABN #256905) conducted a traffic stop at W Hillsborough Ave at N Hoover Blvd on a silver Hyundai Tucson, bearing FL tag QBVL78 (VIN: KM8JU3AC2AU110220), for operating a vehicle at night with the headlights off. Deputy S. Davidson observed the defendant operating the vehicle and detected signs of impairment. The affiant responded to the scene, detected an odor of an alcoholic beverage emanating from her breath and her eyes were bloodshot and glassy. The affiant requested the defendant perform Standardized Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful breath sample to determine her breath alcohol content (BrAC). Breath Technician Yuman Romero #261711 provided me with the defendant's BrAC results and they are follows: First BrAC sample (.213) ; Second BAC sample (.209). The defendant was identified via her FL DL. The defendant was given a DUI citation AAZ6Z9E which reflects the DUI charge.
