Actual physical control (physical evidence putting the driver behind the wheel)

Wormus was observed operating a a 2016 Blue Land Rover west on Clematis St coming to a stop at Clematis St and N Tamarind Ave. At the stop sign, Wormus violated the "right turn only" traffic control sign which is posted directly under the stop sign. Wormus made a left turn, traveling over the double yellow line through the dedicated eastbound turn lane and traveled south on N Tamarind Ave. I conducted a traffic stop making contact with Wormus as the driver, and positively identified him by Florida Drivers License.
