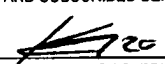

P R O B A B L E	On September 23rd, 2025, at approximately 1555 hours, I was dispatched to 6104 Eberts Street, Jupiter, FL 33458, in reference to a trespass after warning. Abigail Kerpsack (W/F DOB: 06/13/2000), was trespassed from the aforementioned address on August 19th, 2025, for two (2) months from the homeowner, John Norris (W/M DOB: 07/19/1995) (Reference CAD #25196736). While en route to the residence, Northcom advised Kerpsack was screaming into the home, banging on windows around the residence, and was at the residence the prior evening, September 22nd, 2025.								
	Upon arrival, I observed a blonde female wearing orange pants and a blue shirt near the front of the residence, who was identified as Kerpsack. Kerpsack attempted to get into her white Jeep Wrangler, but I advised Kerpsack she was under arrest for trespass after warning at 1611 hours. Kerpsack was subsequently placed in handcuffs, which were checked for spacing and double-locked to prevent tightening. Kerpsack was placed in the back of my patrol vehicle (#1803) and I made contact with Norris at the front of his residence.								
C A U S E	Upon making contact with Norris, he advised Kerpsack was fully-aware she was trespassed from his property, and showed a text thread between Norris and Kerpsack advising her to not come to the residence because she is trespassed and Norris will call the Jupiter Police Department. Norris also has video recordings of Kerpsack at his residence on September 22nd and 23rd, 2025. Norris continued to advise Kerpsack arrived at his residence the night prior, September 22nd, 2025, between 2300-2330 hours, but when Kerpsack became aware Jupiter Police were notified, she left the residence. Norris continued to advise he and Kerpsack have known each other for approximately three (3) months and Kerpsack is unable to hold a job, she is not allowed into Admiral's Cove (where her parent's reside) due to her erratic behavior, and her father pays for her apartment in Abacoa, Jupiter, FL 33458. Norris also advised Kerpsack takes Adderall which is prescribed to her, but believes she may be abusing it.
