Kingdom began to record the interaction where it clearly shows, Fulek getting closer to Kingdom and then hit Kingdom's phone and hand with her hand. Fulek who was inside the residence upon arrival, stated that she never hit Kingdom, only her phone. Kingdom provided a sworn statement. Based on the above stated facts probable cause exists to charge Agnieszka Fulek with simple battery pursuant to F.S.S. 784.03(1a1).
