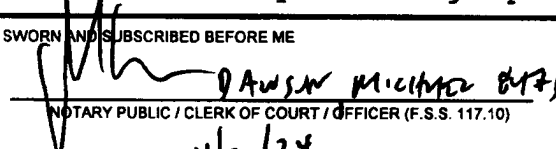
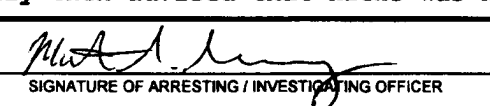

	On the 21 day of November , 2024 at 23:04 (Specifically include facts constituting cause for arrest.)				
C A U S E	On November 21st, 2024 at 2116 hours, I was dispatched to an unwanted person located at the Breakers, 1 South County Road, Palm Beach, Florida 33480. Palm Beach Police Detail Officer Kelly requested a patrol unit to respond to HMF restaurant for assistance. Upon my arrival, I met with Breakers Security Officer Mark Lawrence and Palm Beach Police Officer Max Kelly. Both were standing with a female later identified as Aimee Delcine Hicks (W/F, DOB: 04/30/1983). Hicks was swaying back and forth and was belligerent and argumentative with officers on scene. According to Lawrence, Hicks was drinking at the bar with friends and became irate with staff over her belief in paying the bar bill. Lawrence then attempted to calm Hicks down and requested her to leave. According to Lawrence, Hicks physically was non-compliant and unintelligible with her verbal responses. She started recording Lawrence with her cell phone and when Lawrence raised his hand while requesting Hicks stop recording him, she slapped his hand. Hicks was then escorted to the entrance to HMF where I met with Lawrence and Officer Kelly.				
	I then walked with Hicks, Officer Kelly and Officer Lawrence out of the front door of the Breakers. It was at this time; I observed Hicks to be extremely unsteady on her feet and had difficulty walking. At the Valet area, Hicks became physically and verbally more animated. She was cursing loudly and waiving her arms in the air. She stopped walking several times out toward the exit of the property and turned back to walk toward the front doors. She was warned that she had to leave the property several times, and officers attempted to get her friend, identified as Lisa M. Zebrowski (W/F, DOB: 06/19/1988) to call an Uber since Zebrowski was unwilling to take her home due to her belligerent state. Hicks continued to walk out and as we exited the valet area, she yelled again and turned back to walk toward the front again. During this time, there were several guests disturbed by the behavior located in the valet area. Officer Kelly and I then attempted to physically stop Hicks from walking back and she immediately yanked back and away from our grasp. Officer Kelly then advised that Hicks was now under

arrest and Hicks remained physically non-compliant. She continued to resist handcuffing to the point in which she fell over the hood of a vehicle that was parked at valet. Substantial force was required to overcome Hick's resistance and required her to be escorted to the ground for controlled handcuffing.

Hicks was then placed under arrest and inside a patrol vehicle.

Hicks is charged with F.S.S 810.08 (1) Trespassing, F.S.S. 856.011 Disorderly intoxication, and F.S.S 843.02 Resisting officer without violence.
