PROBABLE CAUSE CONTINUATION

Defendant:
ALBERTO RIABOUKHA

At first, the driver denied consuming alcohol. Sgt. McCluskey requested the driver's license, registration, and proof of insurance. While searching for these items, the driver clumsily dropped cash onto his lap. His hands moved slowly and deliberately, and he slouched forward while seated. The driver stated he was coming from Scores Gentlemen's Club, located at 3174 S. Congress Ave., Palm Springs, FL 33461. Sgt. McCluskey identified the driver as Alberto Riaboukha (W/M, DOB: 01/01/1977).

The driver admitted to consuming vodka and a Red Bull. He explained that he felt unwell and wanted to call his wife and son for a ride home. Officer Millien #252 and I responded to assist. Sgt. McCluskey requested that the driver submit to standardized field sobriety exercises to determine if he was safe to operate a motor vehicle. The driver repeatedly asked for an opportunity to obtain a ride home.

Sgt. McCluskey explained the Taylor warning and advised the driver that refusal to submit to the roadside exercises could be used against him in court as evidence. This was explained multiple times, and multiple requests were made. The driver refused to answer and continued asking to contact his wife and his son. Sgt. McCluskey informed the driver that his refusal to respond would be considered a refusal to submit to the exercises. The driver continued to refuse to answer any of the officers on scene.

Based on my investigation, including the information provided by Sgt. McCluskey, the driver, was placed under arrest for DUI.

Riaboukha was handcuffed behind his back, checked for proper fit, and the cuffs were double-locked for safety. A search incident to arrest was conducted, after which Riaboukha was secured in the rear of my marked patrol vehicle (PS 248). While placing Riaboukha into my vehicle, I detected the odor of an alcoholic beverage emitting from his breath as he spoke.

Riaboukha was transported to the Palm Beach County Main Detention Center. While traveling in my patrol vehicle, his speech remained slightly slurred.

At the facility, Riaboukha refused to do the Breath Test for the purpose of determining his breath's alcohol content and was read the DUI Implied Consent for Breath Test, which he stated he did not understand (after it was explained to him multiple times), but still refused to submit to the test. He was then read his Constitutional Rights, after which he declined to answer any questions and advised that he wanted his lawyer. All necessary DUI paperwork was completed, and Riaboukha was turned over to jail staff for processing.

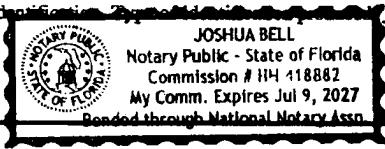

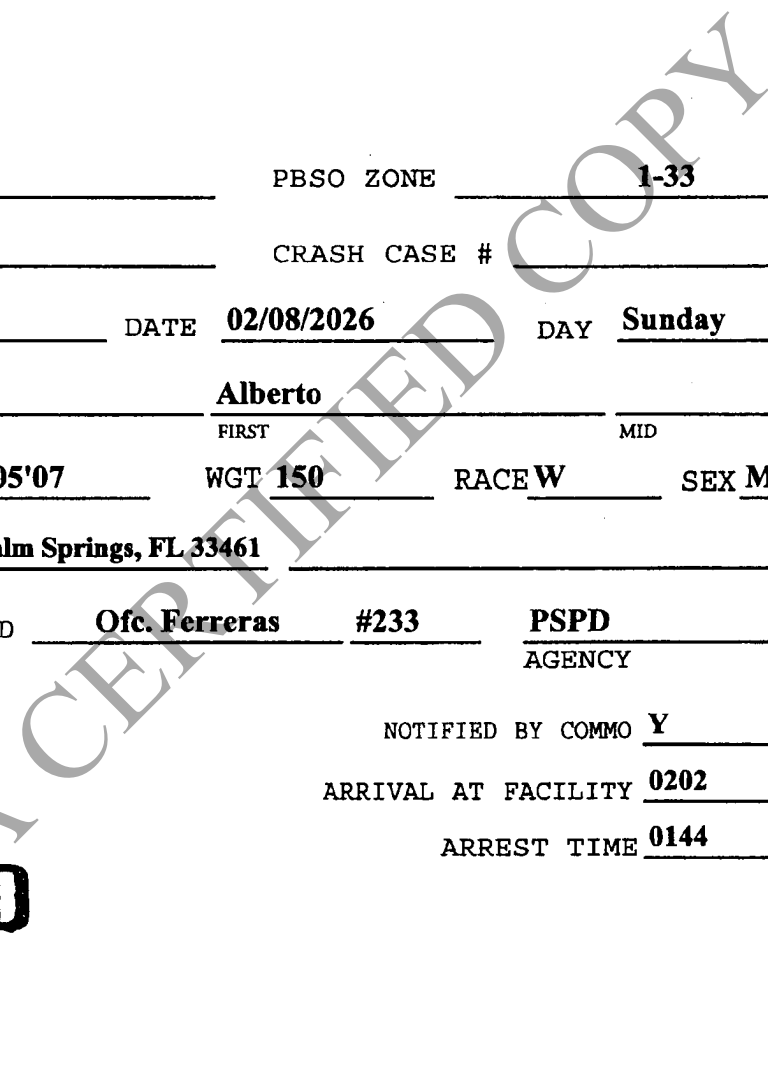
