I did observe multiple injuries on Corellis during my interview with her. These included: redness, bruising, swelling, bleeding of the facial area, redness and bruising of the neck area, swelling on top of head area, visible marks on both her hands and wrists, and a visible scratch on her back area.

Fanjul was placed under arrest at 2335 hours. Search incident to lawful arrest, a small glassine envelope containing a white powdery substance, that based on my knowledge, training and experience as a police officer is believed to be cocaine, was found in Fanjul's wallet. Fanjul's wallet had been removed from his person from his back left pant pocket. Substance was weighed at 0.31 grams.

Fanjul was determined to be the primary aggressor of a domestic violence incident and was placed under arrest at 2335 hours. Based on the facts listed above, I had probable cause to arrest and charge Alexander N. Fanjul with the following charges:

One count of Felony Domestic Battery by Strangulation as pursuant F.S.S. 784.041 (2) (A) in which Fanjul did knowingly and intentionally, and against the will of Corellis, apply pressure on the throat or neck or block the nose or mouth of Corellis, impeding the normal breathing or circulation of the blood so as to create a risk of or cause great bodily harm and that Corellis is in a dating relationship with Fanjul, contrary to Florida Statute 784.041(2) and (3).

One count of False Imprisonment as pursuant to F.S.S. 787.02 (1A) in which Fanjul did forcibly, by threat, or secretly confine, abduct, imprison or restrain Corellis, against her will and without lawful authority, contrary to Florida Statute 787.02(2).

One count of Robbery as pursuant to F.S.S. 812.13(1)(2)(C) in which Fanjul did knowingly take away the purse and cellphone from the custody of Corellis, , with the intent to permanently or temporarily deprive Corellis of the property and in the course of the taking there was the use of force, violence, assault, or putting in fear, contrary to Florida Statute 812.13(1) and (2) (c).

One count of Tampering with or Harassing Victim as pursuant to F.S.S 914.22(1) in which Fanjul did knowingly use intimidation and physical force, with intent to cause or induce Corellis to hinder, delay, or prevent the communication to a law enforcement officer information relating to the commission or possible commission of an offense by preventing her from calling 911, contrary to Florida Statute.

One count of Criminal Mischief as pursuant to F.S.S. 806.13 (1) (B) (3) in which Fanjul did willfully and maliciously damaged, and committed an act of vandalism to Corellis iPhone, causing damage over \$1000.

One count of Possession of Cocaine as pursuant to F.S.S 893.13(6)(a) because Fanjul was knowingly in actual or constructive possession of cocaine, a controlled substance.
