I. WHAT: Boating Under the Influence of Alcohol
 II. WHEN: July 4th 2023 approximately 10:30PM
 III. WHERE: Palm Beach County / Lake Boca Raton ICW
 IV. WHO: Sedlak, Alexander P. 9/4/2000

V. Other information Relating to BUI

Open Motorboat Jet Drive vessel bearing Florida Registration number FL6928SS. Registered Owner is listed as Michael Juliano but Sedlak has a bill of sale from April 2023.

VI. DETAILS OF BUI

A. Phase 1 – Initial Observation of vehicle/vessel in operation

I observed the vessel on the Lake Boca sandbar in Boca Raton on the ICW in Palm Beach County, FL. I observed a vessel with no navigation lights and approached in order to ask the operator to turn the Navigation Lights on.

B. Phase 2 – Personal Contact with operator of vessel

The Operator and co-owner of the vessel was Identified by Ohio Drivers License Number UR562158 as Alexander Paul Sedlak. When I contacted Sedlak, I asked him to turn on his navigation lights and anchor light. Sedlak was unable to figure out how to turn the lights on but claimed that it was one of his first times taking the boat out.

Sedlak avoided eye contact and the boat had multiple open and empty white claw cans and other alcoholic beverages. I conducted a safety inspection for the vessel and the operator was unable to locate multiple items that were asked for. I asked Sedlak how much he had to drink today to which he replied he had about 4 white claws and mentioned that he took one shot.

C. Phase 3- Pre-arrest screening and Observations of Driver/Operator

I asked Sedlak if I could check his eyes since he had admitted to drinking and I wanted to ensure he was okay to drive. I attempted HGN from across the vessel, but there was too much movement to be accurate. I asked Sedlak if he would come over to our vessel so I could see better to which he agreed.
