[REDACTED] stated that when they arrived [REDACTED] wanted to stay inside the vehicle, and watch movies from his tablet, so Alexander Coleman left him inside the car and went inside to play squash. [REDACTED] advised after a short time the vehicle turned off, locked, and the air conditioning turned off, while [REDACTED] was still inside the vehicle. [REDACTED] stated that [REDACTED] began to call for help, but no one could hear him, so he began to hit the window and kick it, eventually he was able to push the window out slightly and air began to flow inside the vehicle. [REDACTED] stated that is when [REDACTED] was able to get help, and two men went inside and retrieved Alexander Coleman's cellphone and unlocked the car and [REDACTED] got out. When we asked [REDACTED] if she was there for this interaction, she stated "no", she advised that she was told about the incident from [REDACTED] and the [REDACTED] (W/F DOB 04/19/2001).</p> <p>I then spoke to [REDACTED] and she stated the following via sworn verbal statement: [REDACTED] advised that Alexander Coleman told her to be at the residence at 1500 hours, however she was busy, so he told her to pick [REDACTED] up at the squash game. <p>she began to bring [REDACTED] back to Alexander Coleman's residents, however, [REDACTED] wanted him at her house due to her feeling [REDACTED] wasn't safe with Alexander Coleman.</p> <p>I then spoke to [REDACTED] and he stated the following via sworn statement: [REDACTED] advised that Alexander Coleman took him to a squash game, but he wanted to stay inside the vehicle and watch his iPad. That is when Alexander Coleman left the door cracked and car running while he went inside the building. [REDACTED] advised that after fifteen minutes, the vehicle's door closed, locked, and the air conditioning turned off automatically due to it being an electric vehicle. [REDACTED] stated he began to scream for help, but no one could hear him or see him as the windows were tinted. [REDACTED] stated approximately fifteen minutes into being locked inside the vehicle, he took off his shirt in attempts to cool down, he also removed a popsicle from his lunchbox and began to eat it and was able to slightly cool down. [REDACTED] advised that is when for approximately 45 minutes he hit the window with his tablet in attempts to break the window however he couldn't. [REDACTED] after he wasn't able to break the window with his tablet, he began to kick the window and it pushed out slightly, which he was then able to get air through the crack, while screaming for help. [REDACTED] stated that two men came over to the vehicle, and he told them that he was locked inside the vehicle and was unable to open it due to it being locked, and to go get [REDACTED]. Shortly after the two males came outside with Alexander Coleman's cell phone and unlocked the vehicle using the cellphone. [REDACTED] advised that while locked in the vehicle, he was just hot and didn't feel like he was going to pass out, he also stated the only pain he was feeling was in his hips, and that it was from kicking the window. It is to be noted, [REDACTED] advised us that while he was locked inside the vehicle, he was afraid for his life and thought he was going to die. [REDACTED] stated that [REDACTED] was ok and didn't need to be checked out by West Palm Beach Fire Rescue.</p> <p>I then spoke to Alexander Coleman, and he provided the following preliminary statement: Alexander Coleman stated that he was at the club and left [REDACTED] inside the vehicle, and that he was upset that [REDACTED] put three indents in the window. When I asked him if I could see the vehicle in question, he stated no. It should be noted that the vehicle was parked in the garage. At that moment Alexander Coleman asked if he should have a lawyer present, that is when I read Alexander Coleman his Miranda Warning, and he advised that he wanted a lawyer. That is when Alexander Coleman was placed in mechanical restraints that were checked for proper fitting and walked to my marked patrol vehicle.</p> <p>Based on the totality of circumstances, probable cause exists, and Alexander Coleman was placed under arrest for Child Neglect in violation of F.S.S. 827.03(2) (d).</p>




