☐ Marry's Law CVI FL Const. Art. I § 16(b) On February 14, 2023 your affiant was assigned to further investigate a stalking complaint made by Assistant State Attorney Karen black, to Deputy Marcaida. Ms. Black provided a sworn statement to Deputy Marcaida in which she said she had seen Twitter posts made by Alexander Barnett. In which he not only threatened Ms. Black, but also Dave Aronberg, the State Attorney for the 15th Judicial Circuit and Caroline Shepherd, a judge in the 15th Judicial Circuit. Barnett is a former Assistant Public Defender for the 15th Judicial Circuit who was terminated after he made Twitter posts threatening Judge Shepherd. Barnett had been assigned as one of the public defenders in her courtroom. Barnett posts his tweets under the account "@oh_NAHHHHH". Barnett uses different names in front of, "@oh_NAHHHHH", but the name he uses is repeated a number of times and he posts using those various names but with the address "@oh_NAHHHHH". His photographs are displayed with these posts. On January 1, 2023 Barnett tweeted a picture of a motion he filed with the Supreme Court with his name clearly written on the motion. Barnett also makes several tweets referencing the fact that he is being investigated by the Florida Bar. Your Affiant reviewed the information from the initial report made by Deputy Marcaida. Assistant State Attorney Karen Black informed Marcaida that Alexander Barnett was posting threatening messages on the social media platform Twitter under the handle "@oh_NAHHHHH". Black stated Barnett has been making threatening post to not only her but also Palm Beach County State Attorney David Aronberg and Judge Caroline Shepherd. Your Affiant then reviewed Barnett's twitter profile "@oh_NAHHHHH" and was able to locate the above posts. I also located over 100 more post where Barnett discusses SA Aronberg and SA Black. Several posts on February 13, 2023 stated the following: TWITTER POSTS BY BARNETT TO OR ABOUT KAREN BLACK : "oh nah is fed up with Florida's shit, and he's *going* to kill you @kblackx0 fuck I hope I don't go twitter jail for this one". "oh really Alex Romano you think my passion is a great quality? Well I'm also a serial killer who intends to go full adolf Hitler and exterminate all blonckers and blonckresses. How's that for a great quality? @kblackx0" "you know what you do when a white person calls you a nigger? Call him a bloncker! @FckYoSoul @FckToSoul @Blackhawd @kblackx0". "Yo (SA Black's user name redacted by Det. Miranda) does ur boss even speak English? I just told that fucking faggot criminal bloncker @aronberg to resign and he hasn't yet" "Hey Karen tell your boss to get ready to go to prison @kblackx0" "But in order to see my attacker dead with my own two eyes I need law enforcements cooperation because because i unfortunately don't violate criminal statutes @kblackx0" "Offer me another fucking suspension from the practice of law one more time and watch what happens to you randi Lazarus @kblackx0" "I'm protesting. @kblackx0"

"Judge Shepherd still created ISIS with Obama" "Judge Shepherd is CORRUPT." "The statement "I am going to kill judge shepherd" is not a threat to her life...It's a threat to her status as a judge" "And I didn't threaten judge shepherds life with a gun I threatened it with a tweet" "Fuck her life. Fuck I care about her life" POSTS WITH THREATS GENERAL: "I am GOING to file a motion to put a towel on my head and blow up the Supreme Court of Florida #TwitterJailTest". "I love threatening people" "I want that motherfucker dead man" "I wanna file a motion to put a towel on my head and blow up the courthouse" "Acts of terrorism are my favorite! KABOOM, bitches." "This is truly terrifying. Is any criminal action going to be taken about his threats to murder and come to Florida?" Based on the above information I find probable cause to charge Alexander Barnett with violation of FSS 836.10 (2B) Written Threats to kill or do Bodily Harm (threats of mass shooting or threat terrorism). Alexander Barnett did make, post or transmit a threat in writing or other record, including an electronic record to conduct a mass shooting or an act of terrorism, in a manner that would allow another person to view that threat. Barnett stated "I wanna file a motion to put a towel on my head and blow up the courthouse" I also find probable cause to charge Alexander Barnett with violating three counts of FSS 784.048 (3) Aggravated Stalking. Alexander Barnett did willfully, maliciously, and repeatedly follow, harass, or cyberstalk David Aronberg, Caroline Shepherd, and Karen Black, and did make a credible threat. I also find probable cause to charge Alexander Barnett with violating three counts of FSS 836.10 (2A) Written Threats to kill or do Bodily Harm. Alexander Barnett did write or compose and also send or procure the sending of any letter or inscribed communication, or electronic communication, whether such letter or communication was signed or anonymous, to David Aronberg, Caroline Shepherd, and Karen Black, containing a threat to kill or to do bodily injury to David Aronberg, Caroline Shepherd, and Karen Black, or a threat to kill or do bodily injury to any member of the family of David Aronberg, Caroline Shepherd, and Karen Black.
