UPON MY ARRIVAL I MET WITH A POPSTROKE EMPLOYEE JUSTIN KADIN. KADIN ADVISED ME THAT HE HAD A VIDEO OF THE INCIDENT FROM POPSTROKES BAR CAMERA. I OBSERVED THE VIDEO. THE VIDEO SHOWS AT 2216 HRS A W/F WEARING A BLACK TOP AND JEAN SHORTS SITTING AT THE BAR TALKING TO THE BARTENDER DAKOTA THERESA DEMARCO. I OBSERVED THE SUSPECT TAKE THE APPLE JUICE CARDBOARD DRINK THAT HAD A STRAW IN IT OFF THE COUNTER AFTER DAKOTA PLACED IT ON THE COUNTER. THE SUSPECT SQUEEZES THE APPLE JUICE AND I CAN SEE THAT IT WENT ALL OVER THE BARTENDER DAKOTA SHIRT AND HAIR. DAKOTA TURNS HER HEAD AND THE SUSPECT THROWS THE APPLE JUICE CARTOON HITTING DAKOTA IN THE BACK OF THE HEAD.
