**Probable Cause**

On February 7, 2026, at approximately 12:22 A.M., I (Trooper Lafleur ID#5261), was on routine patrol in my fully marked patrol vehicle (FHP3475 Vin # 2C3CDXAT0PH639153) with a speedometer calibration date of 11/14/2025 and identifiable Florida Highway Patrol painted insignias. I was traveling northbound on Interstate 95 (State Road 9) just north of Hypoluxo Road in the outside center lane of travel. I observed a white Acura passenger vehicle bearing a Florida license plate of "FPTI37" and a dark in color motorcycle traveling in the inside center lane of travel at an extremely high rate of speed. I visually estimate the vehicles to be travelling at 130 miles per hour in a 65 miles per hour zone. I then began to follow the vehicle and the motorcycle, never lost visual. Both drivers were driving extremely fast (high rate of speed). Both drivers showing a willful or wanton disregard for the motoring public. Based on my training and experience the motorcycle and the vehicle appeared to be racing. I followed them for approximately two to five miles. At one point the motorcycle and the vehicle were traveling side by side and one would overtake the other. While traveling northbound north of County Road 812 (Lantana Road) the white Acura changed lanes without using a signal. Once I got close enough to the white Acura, I pace clocked the vehicle for approximately a quarter of a mile at a speed of 139 miles per hour in a posted 65 miles per hour zone. A short time later, I accelerated to get closer to the vehicle. I activated my emergency blue lights and sirens to conduct a traffic stop on the vehicle for the violation of unlawful speed of 50 MPH above the posted 65 MPH speed limit, and racing.

Upon activating my emergency blue lights and sirens, the vehicle came to a complete stop northbound on Interstate 95 (State Road 9) north of 10th Avenue N in the outside emergency shoulder. Once the vehicle came to a complete stop, I approached the driver's side of the vehicle to make contact with the driver (who was later identified by her Florida driver's license card [W244529852000] as ALEXANDRIA MESHELL WILLIAMS with a DOB of 1/11/2004).

Upon making contact with Ms. Williams, I introduced myself and advised her of the reason for the stop. I asked her to exit the vehicle, and I explained the reason for the stop to the driver and advised her she was under arrest for unlawful speed, and racing as well. I asked her if she was the register owner of the vehicle, and she stated yes. When I questioned her about racing the motorcycle she advised she was just being stupid. While speaking with the driver outside the vehicle, I observed several indicators consistent with impairment. These included a strong odor of an unknown alcoholic beverage emitting from her breath each time she spoke or exhaled, bloodshot, watery, and glassy eyes. I asked her if she had consumed any alcoholic beverages today and she stated no. Ms. Williams advised she was heading home. While interacting with her outside of the vehicle, I continued to smell the strong odor of an unknown alcoholic beverage coming from her breath as she spoke.

Due to the cues and clues that I had observed during my initial encounter with Ms. Williams, I asked her if she would be willing to perform voluntary Standardized Field Sobriety Exercises (SFSE) to aid in determining her level of impairment. After requesting Ms. Williams to submit to field sobriety exercises, she said no and refused to perform the exercises. I then informed her that her refusal to do the exercises could be used against her in court and that I would have to make a decision based upon my observations thus far. I asked her if she understood. She stated yes and refused to perform the exercises.

Based upon the above information and the totality of the circumstances, I determined that there was probable cause to believe that as ALEXANDRIA MESHELL WILLIAMS committed the offense of driving under the influence by being in actual physical control/operating a motor vehicle while under the influence of alcoholic beverages, any chemical substance per Florida State Statute 877.111, or any controlled substance per Chapter 893, while her normal faculties were impaired. I advised ALEXANDRIA MESHELL WILLIAMS that she was also being charged with DUI. I placed Ms. Williams under arrest at 12:26 A.M for the above offense and handcuffed her behind her back, double locked, spaced and tightened the cuffs. Mr. After being searched, Ms. Williams was placed in the back seat of my marked patrol (FHP3475) vehicle with the seat belt placed around her for safety. Her vehicle was towed by Sheehan's towing. During inventory of the vehicle I found a box of NUTRL (alcoholic beverage) with multiple open cans that was still cold to the touch and one can that was half empty as well. She was then transported to the Palm Beach County Breath Alcohol Testing (BAT) facility. I conducted a twenty-minute observation period where I ensured that she did not ingest anything by mouth or regurgitate (mouth was confirmed to be empty prior to beginning of the observation period). Ms. Williams was then asked if she was willing to provide a breath sample to determine the alcohol content of her breath. She stated no and refused to provide a sample. I then read the Florida Implied Consent driver's license suspension warning and asked her if she understood. She stated yes and still refuses to provide a sample. The refusal time was at 01:15 A.M. See BAT video footage for a complete account of the incident.

Ms. Williams was then transported to the Palm Beach County jail for booking and processing and charged with DUI, racing, refusal to submit, and unlawful speed of 50 MPH above the posted.

Ms. Williams was issued a DUI citation along with multiple uniform traffic citations. She was booked without incident.

All of the above events occurred in Palm Beach County, FL.



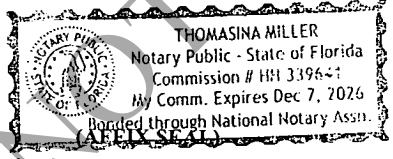
