The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a gray 2021 Toyota SUV bearing Florida license plate HSQS99. The defendant caused a traffic crash when she turned in front of the on-coming victim causing an estimated \$20,000 in damage. The defendant was positively identified as the driver by the victim and the witness, a Tampa Police officer. Additionally, the victim sustained a red mark across her chest and shoulder consistent with a seat belt worn by the driver of the vehicle. Upon contact with the defendant, she displayed several indicators of impairment, to include angry outbursts, yelling profanity, glassy eyes, dilated pupils, slurred speech, a strong odor of an alcoholic beverage that became stronger as she spoke, an admission to consuming four mix drinks at Copper Tail, and an unsteady stance. The defendant performed SFSEs and several clues on impairment were observed. The defendant was placed under arrest and refused to submit to a breath test despite acknowledging her Implied Consent Warnings. The defendant was identified by her Florida driver license.
