The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed address, the defendant entered a verbal altercation with the victim. The altercation became physical when the defendant willfully and intentionally pushed the victim's left flank with their right arm in the entryway of the residence. This action was done against the will of the victim. This action was witnessed by law enforcement. The defendant and victim have resided together for approximately four years and have a child in common, making this incident domestic in nature. While being detained, the defendant willfully and intentionally pushed Deputy B. Bealer (ABN #261771) in his torso with their left hand in an attempt to avoid being taken into custody. After being handcuffed and transported to the marked HCSO patrol vehicle, the defendant grabbed Deputy B. Bealer's duty belt in an attempt to avoid being taken into custody. After being placed in the back of the cruiser, the defendant removed their hand from their handcuffs and advised they are "double-jointed". The defendant was removed from the HCSO patrol vehicle and continued to flex, pull away, and resist law enforcement during handcuffing, also in an attempt to avoid being taken into custody. The defendant was identified via their HCSO booking photograph and FL Driver's License.
