Probable Cause exists to charge and arrest W/F, Alexis Kay Vassel, with one count of Possession of Cocaine, pursuant to F.S.S. 893.13(6)(a). The facts of the investigation are as follows:

On July 12th, 2025, at approximately 1955 hours, I responded to Breakers Hotel located at 1 S. County Rd, Palm Beach, Florida, 33480, in reference to found property. The Breakers Security advised that an a small pink "Louis Vuitton" clutch purse had been turned in by a guest which had found it inside the female restaurant near the Seafood Bar. While employees of the Breakers checked the contents of the purse in order to obtain identification of its owner, a small clear Ziplock bag containing a powdery white substance was located inside. Also inside of the purse was Florida Driver's license belonging to an Alexis Kay Vassel (W/F DOB 11/24/1999). The Breakers Security then notified the assigned Palm Beach Police off-duty detail Sergeant Gordon for further investigation.

Upon my arrival at the Breaker's, I met with Breakers security and the assigned Sergeant Gordon who were in possession of the small pink "Louis Vuitton" clutch purse. To clarify what the unknown white powdery substance inside of the Ziplock bag may have been, a field test was performed utilizing a NARK Cobalt-Thiocyanate Reagent #NAR10013, resulting in an immediate positive test for the presence of cocaine. As the white powdery substance was being tested, a female identified as Vassel had approached Breaker's security inquiring about a missing clutch purse.

A review of Breakers security footage revealed that approximately 1907 hours, Vassel was depicted entering the same female restroom in which the pink clutch had been located. At approximately 1908 hours, Vassel is seen exiting the restroom. Shortly after at approximately 1917 hours, another female was seen entering the bathroom prior to reporting the found property to a Breaker's employee at approximately 1920 hours.

I made contact with Vassel and read her Miranda Rights prior to any further investigation on BWC, for which confirmed she acknowledge and understood. I informed Vassel that her clutch purse had been found and in the process of checking the contents for identification, a small clear Ziplock bag with white powdery substance was found inside. I then proceeded to ask if she was aware of it being inside and what it was, to which she replied, advising it wasn't hers, but that she had an idea of what it could have been.

When questioned again what she thought the bag with white powdery substance was, she then said she wasn't sure because she didn't purchase it. Vassel confirmed that she was in possession of the ziplock bag with white powdery substance because she was the only person who was carrying a bag. All questioning and statements were captured on BWC. Vassel was then advised that we already knew it was cocaine and that due to it being in her possession, she was being placed under arrest for possession of narcotics. Vassel was transported to the PBPD for further interview.

While at the PBPD, Detective Ward conducted a brief interview with Vassel who then admitted she knew the Ziplock bag in question was cocaine. Vassel also admitted to doing a "line" in bathroom herself, and mentioned she purchased the cocaine in Ft Lauderdale, Florida. The Ziplock bag containing the white powdery substance had a weigh of approximately 0.83 grams.

Based on the above facts and circumstances, Probable Cause was established to arrest and charge Alexis K Vassel (W/F DOB 11/24/1999) with one count of F.S.S 893.13(6)(a) Possession of Cocaine, due to her having it in her possession and admitting to purchasing as well as using the cocaine. Vassel was transported to PBSO county jail for processing.
