Art.1 § 18(b) On June 12, 2023 at approximately 1900 hours I responded to the WaWa Gas station located at 3950 S Congress Ave, Palm Springs FL in reference to a Domestic Dispute. Prior to my arrival I made contact with D/S S. Anderson/32400 who briefed me on the incident. Upon arrival I made contact with D/S Anderson who introduced me to the victim now known as Hailey Smith and her boyfriend Jacob Mangold. I asked Smith what occurred today and she stated that Mangold has a one year old child with a woman who is now known as Ali Baker. Baker and Mangold ended their relationship in January of 2023. When the relationship ended, Baker moved out of their residence which is located at 3117 French Ave, Lake Worth FL. Mangold had the locks changed and kept the residence. Smith stated that one June 11, 2023, Baker found out that Smith was moving in with Mangold. Baker became upset and called Mangold on his cell phone. Mangold put the phone and speaker and recorded the conversation. During the conversation between Baker and Mangold, Baker stated that she plans to kill Smith and didn't want Smith with Mangold. During the conversation, Mangold told Baker to stop and move on from the relationship and Baker replied that every time she sees Smith she plans to "beat her" and "kill her". Mangold then stated to Baker that she needed to stop and Baker said that she can be 45 years old and if she seen her she will "beat her". Mangold then told Baker to think about their child and that if she hurt Smith, Baker would end up in jail and Baker replied that she will beat her and not go to jail because Smith won't tell the cops since we have a child. Smith stated that Baker has made comments to fabricate stories to get Mangold in trouble if he ever tried to have her arrested. Then on June 12, 2023 Baker asked to come over to the residence to pick up some old property and furniture that she never took. Mangold told Baker that the items were outside in the car port and that she could come on June 12, 2023 after 1800 hours to pick up the property. At 1745 hours, Baker arrived at the residence in a moving truck with 2 unknown males. When Baker arrived, Smith was inside the house with the door closed unpacking items in the house. Mangold was outside attempting to install a ring camera.

Art. 1 § 18(b) Mangold stated that while he was outside on a ladder installing the ring camera Baker exited the u-haul moving truck and began to approach the house yelling at him. Mangold came down from the ladder and told Baker that she was early and that her property was in the car port. Baker then pushed by Mangold and opened the door to the residence and entered the residence. Once inside Baker ran inside and began to yell at Smith. Baker then pushed Smith down to the floor and Mangold jumped between them to stop Baker from hitting Smith who was on the floor. One of the unknown males who was with Baker then ran inside and pulled Baker outside. Inside the house with Smith was her friend Jillian Blitzer who witnessed the entire event. After Baker was taken outside, Mangold had Smith and Blitzer go out another exit of the residence to go to their vehicle and leave the area. When Smith got outside to her vehicle, Baker ran over and began hitting her vehicle yelling for Smith to get out of the vehicle. Blitzer and Smith were eventually able to get out of the driveway and pull away from the residence. Smith then drove over to the WAWA to call for law enforcement. Smith and Mangold confirmed that Baker doesn't live at the address and that she doesn't have a key to the residence. Smith stated that she is on the lease for the apartment with Mangold. Both Mangold and Smith confirmed that they didn't give Baker permission to enter the residence at any time. Smith also received a message from a friend that Baker posted a picture of Smith on social media and stated that if anyone sees Smith to beat her ass. At approximately 2200 hours I responded to Baker's residence located at 244 Walton-Heath Drive, Atlantis FL to speak with Baker. Upon arrival I met with Baker's parents who stated that Baker was currently not home and with her boyfriend, but called Baker to come home. When Baker arrived I met with her at the vehicle. Baker requested to speak with me without her family present. I then read Baker her Miranda warning from a PBSO issued Miranda warning card. Baker stated that she understood her rights and wanted to speak with me about the incident. I asked Baker what occurred tonight and she stated that she made arrangements with Mangold to go over to his residence by 1800 hours and pick up her belongings that was left behind when she moved out. At first Baker stated that when she arrived and noticed Mangold and Smith at the residence she stood in the truck until Mangold went into the house. Then Baker admitted to entering Mangold and Smith's residence without permission but stated that she only yelled at Smith. When I asked where Mangold was when she went inside the residence she stated that he was outside because she just went inside. When Smith went outside, Baker admitted to yelling at Smith outside then collected her property and left.

Art. 1 § 18(b) I then asked Baker if she ever made any threats to hurt or kill Smith and she stated that she has never threatened or touched Smith. When I stated that there was a recording of her making threats to kill and beat Smith she stated "he recorded me". Baker stated that she messages through a court app with Mangold but stated that her phone was at her boyfriend's house. When I told her that her mother was just on the phone with her while she was coming so we knew she had her phone she stated that she didn't want to show Detectives the messages between her and Mangold. Based on the above information Ali Baker was charged with Burglary with a battery, a First degree felony punishable by life and with Aggravated Stalking, a third degree felony. I followed up on the investigation and listened to Baker's jail telephone calls. On June 13, 2023 Baker called her father now known as Robert Baker at 0044 hours. Baker identified herself by stating her name and Robert accepted the call. While speaking, Baker admitted to Robert that she did threaten Smith. Robert then stated to Baker that Baker's new boyfriend now known as Jerome Clark was calling Mangold to have the charges dropped. Baker then called Mangold approximately seven times. During the calls Baker tells Mangold "why is he doing this" "please help me". Mangold keeps telling Baker that he can't speak with her and that she will be ok. At 0730 hours, Baker called Mangold and asked if Smith was going to drop the charges. Mangold told Baker that he needs to hang up and that he will not speak about the incident. On 0749 hours Baker called Mangold again and told Mangold to tell Smith to drop the charges. At 0724 hours Baker contacted Robert, during the conversation Baker asked Robert if he has spoken with Mangold and Robert and he stated no. Baker then asked Robert to speak to Mangold to have him tell Smith to drop the charges. It should be noted that at 0728 hours, Mangold received a text message from Robert that stated "you need to do something about this Jake you need her to drop the charges and do it fast". I then received a phone call from Mangold, who stated that he received text messages from Robert and Jerome. Mangold showed me the message from Robert and then Jerome. The message from Jerome stated "I know Ali flipped out and she's not in the best mental headspace. But you have no idea what getting an abortion does to a woman mentally. She literally killed her child. No man will ever bare that pain. And I know she's been off the wall. But she is really going through it. I just hope you do the right thing and not follow through with these charges, and also try to talk your gf into the same." "please just don't press charges let it all get dropped". Then Jerome texted Mangold again at 0736 hours that stated "I want you to consider if you go through with these charges and Ali gets these felony's and loses her teaching job. After the baby court is settled you are going to have to pay her a shit more money because of the income difference since she will probably be working at a restaurant the rest of her life". Then after first appearance at 1028 hours Jerome sent another text that stated "they denied Ali bond and the judge said she's looking at life in prison" "Don't do this jake that girl needs to drop these charges". Based on the above information I find probable cause to charge Ali Baker with violation of FSS 914.22 (1) and (2)/ Tampering with a witness, victim or informant.
