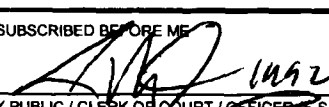

On July 2, 2023, while working as a fully uniformed patrol officer for the West Palm Beach Police Department. I responded to 830 El Vedado in reference to a disturbance. Upon arrival I made contact with the reporting party Russ Blanton W/M (04/22/71). He advised the following: His mother Carol Blanton is in Hospice care and the care taker Alicia Branch-Stafford W/F(09/15/78) has been at there house all day taking care of her. Blanton advised at some point Stafford began drinking alcohol. Blanton called her son because Stafford was becoming belligerent. Russ arrived at the residence at approximately 1830 Russ arrived and observed Stafford being belligerent. Russ asked Stafford multiple times to leave the residence. She refused to leave. Russ even called her an Uber, but Stafford refused to leave. Russ advised officers he wanted Stafford removed from the residence. Officers arrived and began speaking to Stafford advising her she needs to leave the residence Stafford refused. She stated she's not leaving. Officer attempted to reason with Stafford. She would not listen. Stafford moved forward towards officer Mendez in and aggressive manner. Stafford bowed her chest in an aggressive manner as if she was going to fight. Ofc Mendez placed her arm up and told her to step back. I stepped in front of Stafford and grabbed her arms to control her. At this point Stafford raised both her hands up and struck me in the chest pushing me away. My self and Officer Mendez attempted to control Stafford by using a soft control technique and pulled her arms away by turning and facing officers. She pulled away and actively resisted officers. Preventing officers from taking her into custody. Stafford was controlled to the ground to the ground placed her in handcuffs, Stafford was controlled to the ground without injuries. Based on the above facts Probable cause exists to charge Stafford with one count of battery 784.07(2B) BATTERY - OFFICER, FIREFIGHTER, MEDICAL CARE PROVIDER and one count
