On April 17, 2025, your Affiant found probable cause to arrest and charge, W/F Alina Shimova (DOB 12/27/1985) with 1 Count of Offer to Commit Prostitution pursuant to F.S.S. 796.07(2)(d) The facts are as follows:

On April 2, 2025, SIU received information that a Russian female identified as Alina Shimova was soliciting males inside the Brazilian Court Hotel for "friends with benefits" in exchange for \$3,000.00. SIU was provided with a contact number of 305-767-5223.

On April 16, 2025, your affiant contacted Shimova (305-767-5223) via text message, stating that her number was given to your affiant from a friend from the Brazilian Court Bar and if she was interested in getting together. Shimova replied via text message that she was "looking for friends with benefits" and Your affiant replied that he was looking for the same. Shimova then replied via text if \$1K with a emoji of a rose, which is a term commonly used by sex workers and prostitutes, next to it and asked if that works with your affiant. Your affiant agreed and asked if she was available to meet at the Brazilian Court Bar on April 17, 2025. Shimova replied that she was available on April 18, 2025, which your affiant agreed and informed that a room would be obtained. Shimova replied that she will be driving almost 2 hours from Miami and stated that she has a minimum of 2 hours, your affiant than asked Shimova if she would do 4 hours, and she replied that would be perfect and said she would do that for \$4k and added a rose emoji. Shimova then requested a deposit, claiming it's a long drive and she doesn't know your affiant. Your affiant replied that he would be paying with cash and Shimova responded she wanted a confirmation that your affiant was serious and not the "police". Your affiant later replied that there were concerns that Shimova may be trying to pull a scam as well and told her that there must be trust with each other. Your affiant then stated that he would be at the bar at 830 and was hoping they could connect. Shimova then replied that her schedule changed and was able to meet on April 17, 2025, at 7 pm, which your

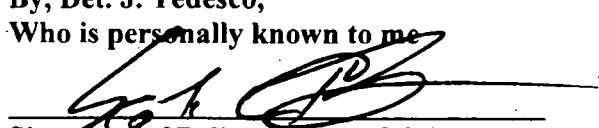
On April 17, 2025, Your affiant went to the Brazilian Court Bar as agreed upon and sat at the bar, waiting for Shimova to arrive as planned. At approximately 7:34 pm a W/F entered the bar wearing a black dress and white blazer who I believed to be Shimova. She approached your affiant at the bar during which time we engaged in conversation. Shimova stated that everything goes and she doesn't waste time. Your affiant then asked Shimova if I could ejaculate twice, and she stated yes. Your affiant then asked Shimova if I could ejaculate on her face, and she replied yes that would be so good.

Upon Shimova agreeing to a sexual act in exchange for \$4k in currency, Your Affiant gave a predetermined arrest signal. Palm Beach Police Officers entered the Brazilian Court lobby and placed Shimova into custody. At the time of her arrest, Shimova was positively identified by her Florida Driver's License # S609-630-17-500-0. A search of Shimova's purse resulted in the recovery of five condoms and personal lubricant along with \$270.00 in US currency which was seized as evidence.

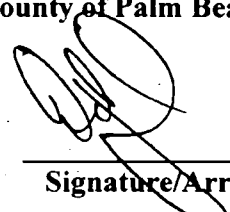
Based on the investigation, your affiant found Probable Cause to arrest and charge Alina Shimova with the following:
