### WALK AND TURN:

Berman was walked to a well lit and level surface area, at which time I utilized a blue tape for the straight line. Berman confirmed the line appeared straight with no obstacle. The exercise was explained and demonstrated to Berman and she stated she understood. During the instruction phase, Berman stepped of the line and unable to maintain her balance 3 times.

During the walking phase, Berman missed heel to toe on every steps and took 12 steps both ways. Berman stepped off the line, used her arms for balance and made an improper turn.

### **ONE LEG STAND:**

The exercise was explained and demonstrated to Berman and she stated she understood. The following clues were observed: Berman used her arms for balance, and put her foot down.

### **FINGER TO NOSE:**

The exercise was explained and demonstrated to Berman and she stated she understood. Berman failed to return her arms to her side after every call.

### **ROMBERG/ALPHABET:**

The exercise was explained to Berman and she stated she understood. Romberg was administered and Berman estimated 1 minute and 58 seconds when she was asked to estimate only 30 seconds.

Based on my investigation, Berman was arrested for driving under the influence of alcohol at 00:16 hrs (Handcuffed, D/L and checked for spacing) and was transported to the Palm Beach County BAT in my vehicle (905).

I arrived at the BAT at 00:47 hrs at which time I started my 20 minutes observation. Once completed, Berman was asked to provide samples of her breath for the purpose of determining the alcohol content and she agreed. Berman provided the 1<sup>st</sup> breath sample at 01:14 hrs for (.206) and the second sample at 01:17 hrs for (.201). Q/A's were not completed after Berman refused.

Berman, Allison Joy was charged with DUI .150 or higher pursuant to F.S.S 316.193(4). Berman was processed and booked at the Palm Beach County jail.
