The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On this date and time the defendant was operating Florida Tag LQKB74 on a white colored Nissan/Rogue. I stopped the vehicle for suspicion of DUI after observing it's unusual manner of operation. As the vehicle was stopped for the red traffic signal at the intersection of N. Howard Ave and W. Kennedy Blvd (traveling northbound), the vehicle was stopped beyond the stop bar (rear tires at the stop bar) and when the traffic light cycled to green, the driver had a delayed reaction to the green signal, but eventually began travel. As the vehicle traveled northbound on N. Howard Ave, it drifted out of proper lane position weaved from side to side and hugged the right side lane marker. As the vehicle approached the on-ramp to I-275 (northbound) the driver failed to stop for the red traffic signal and turned without proper signaling. The vehicle traveled northbound on I-275, at an unsafe distance to the vehicle to its front (following to close) and the driver constantly kept breaking. It drifted out of proper lane position and struck and crossed the lane markers. The vehicle traveled at a high rate of speed (excess of 70-MPH in a 55-MPH travel zone) and the driver made numerous lane changes (weaving in and out of traffic) at an un-safe distance from the vehicles occupying the lanes (almost cutting them off) the lane changes were abrupt (jerk manner) and the signal came after the lane marker had been crossed. I stopped the vehicle on I-275 just before the Sligh Ave exit and made contact with the driver (she had a female passenger), observing she had a slow/lethargic mannerism and appeared to be intoxicated. She had a fixed gaze and her eyes were bloodshot, watery and glassy. In speaking with her, I could smell a distinct odor of an alcoholic beverage coming from her breath and her speech was slurred. She performed the SFSE's and displayed clues of impairment. She was arrested for DUI and transported to CBT/Booking where she provided two valid breath samples, which registered a BRAC of .113 and .113 without incident.
