On 07/06/2025, at approximately 0125 hours, I Officer J. Marino 39572, responded to 1108 S Orange Blossom TRL, in reference to a group of fifteen individuals. Upon arrival, as I was dispersing the crowd, I ordered the individual (Alyssa MCGough) to disperse. She failed to comply with my orders and proceeded to shove an unknown male.

As I approached the individuals to assist in keeping the peace, I witnessed Ms.MCGough, shove an unknown male.

Ms. McGough was removed from the confrontation to prevent further violence. Ms.MCGough was engaged in a physical altercation on 1108 S Orange Blossom TRL in the City of Orlando.

Alyssa MCGough was placed under arrest for violating the Orlando City Ordinance on Disorderly Conduct, which states in 43.06 (c): Any person who shall cause, provoke, or engage in any fight, brawl, or riotous conduct.

Ms. MCGough was placed in handcuffs, which were checked for proper fit and double-locked. The defendant was then transported to the Orange County Jail for processing without further incident.
