The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date, time and location, Deputy A. Rodriguez (ABN: 263162) conducted a traffic stop on a white mini cooper bearing Florida tag BN11ZZ. Deputy Rodriguez responded to the area after a private citizen called in a reckless driver in a smaller white vehicle who was swearing all over the road and ran a red light. Deputy Rodriguez observed the white Mini Cooper fail to maintain its lane and strike the concrete curb/median. Upon contact with the driver Deputy Rodriguez observed the driver displaying indicators of impairment. Deputy Rodriguez observed the drivers eyes to be glossy and watery, her to have fumbling fingers, and her to have slurred speech. Your affiant made contact with the driver and observed her to have fumbling fingers, slurred speech, and her eyes to be red, glossy and watery. Your affiant requested the defendant to perform the Standardized Field Sobriety Exercises, which the defendant agreed to perform. While performing the exercises, the defendant demonstrated signs of impairment, and was subsequently arrested for DUI. Following a proper 20-minute observation period, the driver provided two lawful breath samples. The drivers's first BrAC sample read .181%, and the defendant's second BrAC sample read .184%. The driver was identified via a valid FL DL.
